Subject:- Complain against Shankar Oraon

Sir,

I, Sri Shibu Oraon, son of Late Lal Oraon, resident of Ram Krishna Pally, Mari Road, Ward No. 45 of Siliguri (M.Corp.), P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, in the State of West Bengal, wants to lodged this present complaint against Shankar Oraon, son of Late Lal Oraon, resident of Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, in the State of West Bengal to that effect that, I am the recorded owner of the land measuring 0.16 acres situated within mouza Palash, J.L. no 43, recorded Khatian No. 1111, Plot No. 58, Touzi No. 91, Pargana Patharghata, P.S. pradhan Nagar, Dist- Darjeeling.

That due to my health and family problem I was unable to lookafter and manage my above mention land and for the said reason I had appoint my brother namely Shankar Oraon, as a lawful attorney and a deed of General Power of Attorney was executed by me in favour of my above mention brother being no. 040200544 for the year of 2016, registered in Book No. IV, Vol no. 0402-2016, page from 9418 to 9432, dated 08-07-2016 registered before A.D.S.R. Siliguri on condition that he shall bound to deposit the consideration money in my bank account. As I am an illiterate person and I had a great trust upon my brother.

But very recently I came to know that my brother sold out all the land measuring 0.16 acres to different persons through different deeds on the basis of above mention General Power of Attorney from past few years without giving any knowledge to me, and he did not deposited any amount of money in my bank account. Further, after enquiry I came to know that he sold my all the above mentioned land measuring

0.16 acres in favour of five different persons including his wife. On 31-12-2021 he sold a portion of land in favour of one Miss Manisha Lepcha, vide Deed no. 1-10449/2021 registered at A.D.S.R. Bagdogra, thereafter on 08-03-2022 he sold a portion of land in favour of one Sri Ghono Manki Munda, vide Deed no. 1-2632/2022 registered at A.D.S.R. Bagdogra, thereafter on 15-07-2022 he sold two portion of land in favour of two different persons namely Sri. Rapzong Sherpa, and Smt. Mingma Doma Tamang, vide Deed no. 1-6821/2022 and 1-6822/2022 respectively, registered at A.D.S.R. Bagdogra, thereafter lastly on 16-12-2022 he sold a portion of land in favour of her Wife namely Smt. Signi Oraon, vide Deed no. 1-11357/2022 registered at A.D.S.R. Bagdogra. Thereafter when I asked my brother namely Shankar Oraon, that why he sold all the land without informing me and also why he did not deposited any amount of money in my bank account at that time he threaten me that if I lodged any complain or inform the matter to anyone then he will ruined my life.

I am an illiterate person and I strongly believe that my brother namely Shankar Oraon, taking that advantage intentionally misappropriated all the consideration amount in order to illegal gain and committed criminal breach of trust.

That finding no other alternative I pray before your good self to take necessary legal action against said Shankar Oraon, so that I can get my money back, for the ends of justice.
