Sir,

This is to inform you that on 23.06.2025, one employee of Siliguri Municipal Corporation, namely Sri Choton Mandal, son of Sri Kappe Mandal, was engaged in monitoring newly planted saplings around the riverbed area at Prakash Nagar, Ward No. 43 of Siliguri Municipal Corporation, as part of preparations for the upcoming World Environment Day.

Suddenly, a group of 4 to 5 unknown miscreants, reportedly in an inebriated condition, arrived at the said location and began uprooting the saplings and damaging the adjoining area reserved for tree plantation. Upon witnessing this, Sri Choton Mandal protested and attempted to restrain them from carrying out such unlawful activities. In response, the said antisocial elements turned violent, physically assaulted Sri Choton Mandal, and threatened to kill him if any future attempts were made to carry out plantation activities in that area. One of the miscreants even brandished a broken beer bottle while issuing the threats, further endangering the safety of the municipal staff. At that time, the site supervisor, Sri Subhajit Dey, son of Late Shankar Dey, arrived at the spot. The miscreants also threatened him before fleeing the scene. Subsequently our staff namely Sri Choton Mandal was taken to Siliguri District Hospital for necessary treatment as he sustain several injury.

The incident has created panic among the staff and poses a serious threat to the safety and security of municipal personnel, as well as the integrity of public property. Immediate and appropriate action is requested against the unidentified offenders to prevent recurrence of such incidents and to ensure the safety of ongoing environmental initiatives

Under the above circumstances kindly take the necessary legal action against the wrongdoer.

Treat this matter very urgent and do the needful in this regard.
