Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that: (1) Goutam Seal, S/O- Late Gopal Ch. Seal, Address: East Rabindranagar, Ghogomali Main Road, Ward-38, Siliguri, (near Tilak Sadhu More), P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 & (2) Pijush Sarkar, S/O- Late Naresh Sarkar, Address: Subhaspally, Ward- 19, PO & PS- Siliguri (near Netaji Girls School), District- Darjeeling, PIN- 734001, have committed Theft of Electricity under section: 135(i) (e) of the Electricity Act, 2003, read with further amendments for using the connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) (Ref. Consumer ID: 412101502) as stated here under.

On 23.06.2025 at about 13:20 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bhaben Roy, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II), 3. Mr. Biplab Sarkar, Sr. OE & 4. Mr. Anup Lama, Sr. OE, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of (Late) Gopal Ch. Seal, Address: East Rabindranagar, Ghogomali Main Road, Ward-38, Siliguri, (near Tilak Sadhu More), P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 412101502), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid two accused persons were detected consuming Electricity dishonestly in unauthorized manner by Using the Domestic Service Connection against Consumer ID: 412101502 & Meter No.: B3710614 for Domestic as well as Commercial purpose for the shop called 'Maa Tara Hotel & Restaurant' (a shop managed jointly by the aforementioned two persons & situated at the land of late Gopal Ch. Seal, East Rabindranagar, Ghogomali Main Road, Ward-38, Siliguri, near Tilak Sadhu More, P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006) viz. using the electric connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic). Moreover, during inspection, the last reading was found 14943 KWh dated: 23.06.2025. Thus the service connection was used in unauthorized manner & WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected the Service Connection as per norms and seized one number single phase Energy Meter having Device SI No.: B3710614, Make: Bentec, Rating: 240V, 5-30A, 50Hz, 3200 imp/KWh (L.R.: 14943 KWh) connected with some portion of Incoming & Outgoing wires which has been used for consuming electricity dishonestly in unauthorized manner as described above under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & one of the Accused Person himself. The inspection team members left the aforesaid premises at 14:05 hours on the same day after observing all formalities.

So the accused persons, (1) Goutam Seal, S/O- Late Gopal Ch. Seal, Address: East Rabindranagar, Ghogomali Main Road, Ward-38, Siliguri, (near Tilak Sadhu More), P.O. - Rabindra Sarani, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 & (2) Pijush Sarkar, S/O- Late Naresh Sarkar, Address: Subhaspally, Ward- 19, PO & PS- Siliguri (near Netaji Girls School), District- Darjeeling, PIN- 734001, have committed Theft of Electricity under section: 135(i) (e) of the Electricity Act, 2003, read with further amendments for using the connection for the purpose (i.e. Domestic as well as Commercial) other than for which the usage of electricity was authorized (i.e. Domestic) (Ref. Consumer ID: 412101502).

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
