With due respect I the undersigned would like to inform you that I have entered into the marriage with Sri Sanjay Dey, Son of Late Shankar Dey, Resident of Zenith Apartment, Hakimpara, Ward No. 15 under Siliguri Municipal Corporation, Siliguri and said marriage was solemnized on 17.04.2008 according to Hindu rites and customs at Chinu Bhawan, Hakimpara, Siliguri. After the said marriage I have been brought by my husband in my matrimonial house along with the valuable movables, jewellerys, furnitures as my stridhan properties and I have entrusted the same to my husband and in-laws and I alongwith my husband have started to live together as husband and wife and out of the said wedlock I gave birth of two daughters on 27.03.2017 and 05.08.2021 respectively.

I would like to further inform you that after elapsing of few months after the date of my marriage I found that my husband is a habitual drunker and he used to maintain extra marital relation with so many ladies in a random manner. Almost each and every night my husband used to return in house after having plenty of liquor and he used to abuse me mentally and physically. On several occasions my husband used to put pressure upon me to bring money from my widow mother for starting his new business and on refusal he used to assault me brutally under the impression of liquor. At the relevant time my father in law had been suffering from cancer and whenever my husband used to

manhandle me in that manner, my father in law used to save me and he used to convince me by saying that to keep some patience and everything will be fine and being a newly wedded wife I had swallowed all the pain with a hope for a better conjugal life and due to such continuous torture I have conceived after a long period from the date of my marriage however after the birth of my first daughter I thought that my husband will change but within a very short period I could realize that I was a fool but seeing the family reputation and prestige I could not take the legal action against my husband and taking that advantage my husband has accelerated his quantum of torture upon me on the various pretexts.

I would like to further inform you that due to the continuous torture of my husband I used to keep myself busy in advanced education for a long time just to get peace in my life and also have taken the service in a private school as a teacher.

I would like to further inform you that since few months I am getting that my husband has started to maintain an illicit relation with his girlfriend and he has openly declared that he will continue such relation and nobody can resist him. Yesterday, i.e., on 21.06.2025 from the morning he started to have liquor and at night he returned at home in an intoxicated condition and started to assault me by fists and blows and when my elder daughter tried to save me he have brutally thrashed her too and he have forcibly molested private part of my chest with an intention to give me pain and I sustained serious pain in my private parts and moreover he have abused me with filthy languages by opening his private part and told me that he usually keep the girls like me there and on protest he seriously assaulted me and for saving my life I somehow escaped from my bedroom with my two minor daughters and took shelter in the downstairs and somehow confined ourselves in a room by locking the door from inside but he became very aggressive and furious and tried

to break the door forcibly and I was compelled to call the police and realizing that he stopped the said act for a moment but from the morning today he again started to misbehave with me in the same manner.

Under the above circumstances I would like to request you to investigate the matter and do needful for saving my life of mine and my minor daughters for the ends of justice
