Dear Sir ,

With due respect and humble submission that I Pinki Poddar , w/o Bikash Poddar residing at B R I Colony , Gate Bazar , Siliguri Junction , Siliguri would like to inform you that I have crossed 18 years in my married life with Bikash Poddar . My Sansuri Sila Poddar and my husband all are staying in same residential place. We have two daughter one Son . Since 18 years my Sansuma Sila Poddar and my husband Bikash Poddar have been tortured me by physically and mentally without any reason. But I could not say anything . Oftenly they told me to leave them and stayed alone in other place. This types of situation occurred various time . In the year of 2015 Bikash Poddar along with his mother took me to stayed my father house at Begusarai . At that time I was pregnant . At that time my elder daughter also stayed with me at Begusarai . 5 years I was staying at Begunsarai with my elder daughter . At that time my younger daughter was born at Begunsarai. But my husband did not given any expenses to me for look after my children and did not took me their home. I was faced financial crisis. I lodged a notice to him for maintenance our family . After 5 years my husband negotiate with me and agreed to return back at home with two daughter. But after few months again my sansuri and my husband start to tortured me . In the month of January , 2025 my Sansuri pulled my hair forcibly and try to evacuated me from the house. She and my husband broken my finger of right hand. Till I had showing my patience. On today i.e. 25.06.2025 at about 8.30 am my husband Bikash Poddar and her mother had beaten me brutally by using strong wood and pulled my hair forcible and taken me outside of the house. Even try to kill me by pressuring my neck. I feel huge pain in my , my face , body , my neck , my hand and my back. Both my Sansuri and my husband tortured brutally upon me.

Sir/ Madam , I therefore request you lodge F I R against them and take necessary steps as early as possible.
