Sub - written complaint against one Niloy Goswami

Respected Sir/Madam,

I, Minu Shil, wife of Dinesh Shil, working as maid servant at Haiderpara, currently residing at Khalpara Main Road, Ward No. 7, P.S. Khalpara, P.O. Siliguri, Dist. Darjeeling, permanent address at Chakmoulani, Mal, Jalpaiguri complaining against Niloy Goswami, a lottery seller, that for many weeks, I've been noticing that person namely Niloy goswami is stalking me while I return to home from work. When asked few passerby local ladies about him they told me his name. From past few days he has been disturbing me near Binaymore, pipeline area where he sells lottery tickets, by making bad gestures, saying dirty things, offering me money, and asking me to go with him, making me feel ashamed often infront of passerby people but I've always tried to avoid him. Today on 22.6.2025 at around around 8:00 PM, at the same place i.e pipeline area, binay more, while no one was around, he blocked my way and offered money to go to a hotel room with him and forced me when I denied and tried to walk away, he forcefully grab me by my waist and chest, pulled my saari to take that off, and grabbed my private parts and forcefully kissed me outraging my modesty when I protested he slapped me. I shouted for help, but nobody was nearby then I somehow pushed him away and escaped from that place. I'm deeply scared and hurt after this incident.
