Siliguri Police Commissionerate do hereby lodge the written complaint against one driver namely Vinesh Singh, driver of the vehicle having registration no UP38AT2835 to the effect that on 25.06.25 at about 19:35 hrs as per order myself along with others officers & force while performing the special Checking duty at Gander more under Fulbari traffic out post vide Fulbari Traffic out post C.C No 05/2025. Date, 25.06.2025. During checking time one vehicle having registration no UP38AT2835, loaded with bamboo was detained for checking & requested the driver to produce the driving licence and related documents in respect of vehicle no UP38AT2835 but the driver of the vehicle directly refused to show any necessary documents of the vehicle as well as driving License.
