In producing herewith one accused person namely Mukund Madhab (33 yrs) S/O Sudhir Kr Jha of C/O Pawan Kr Gupta of Circuit House, Barah Patther Chowk, Kashipur, PS+Dist. Samistipur, Bihar under arrest along with following articles under proper seizure Viz: (i) one gray colour Trolly bag styled as "HQ" containing 47 (forty seven) bottles of "ROYAL BLUE" Premium Whiskey each bottle containing 180 ml, i,e total (47 x 180 ml = 8.460 ltrs) marked as Exhibit "A" out of which 01 (one) bottle of the same taken as sample from Exhibit "A" for examination and marked as Exhibit "A1".

I, ASI Biplab Kr Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Mukund Madhab (33 yrs) S/O Sudhir Kr Jha of C/O Pawan Kr Gupta of Circuit House, Barah Patther Chowk, Kashipur, PS+Dist. Samistipur, Bihar to the effect that on 26.06.2025 at 22.10 hrs I received a specific source information that one person possessing and carrying huge quantity of illict liquor without any valid documents is satnding at Siliguri Junction opposite old SJDA Building, under PS- Pradhan Nagar, Dist. Darjeeling and he is waiting for a Bihar Bound Bus. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1150 dated 26.06.25 and I informed the matter to you. Subsequently, being directed by you at 22.15 hrs myself accompanied with SI Rajiv Subba, SI Bandhan Roy, ASI Prabal Sarkar, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for Siliguri Junction by Govt. vehicle to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford him opportunity for concealment of evidence or facility for his escape vide Pradhan Nagar PS GDE No 1551 dated 26.06.25.

At about 22.25 hrs I along with the above mentioned officers and force arrived at Siliguri Juncton near old S.J.D.A. Building under PS- Pradhan Nagar, Dist. Darjeeling and being pointed by the source we noticed that one person possessing a gray colour Trolly bag in his possession is standing there. Accordingly, we cordoned the place from every corner but seeing the police personnel proceeding towards him he tried to fled away from the spot and fell down on the road side drain, causing he sustained minor injury on his person. However, after hot chase we managed to detain him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience) and also informed him about the information in hand. On interrogation, he disclosed his identity as Mukund Madhab (33 yrs) S/O Sudhir Kr Jha of C/O Pawan Kr Gupta of Circuit House, Barah Patther Chowk, Kashipur, PS+Dist. Samistipur, Bihar. On further interrogation he disclosed that he is carrying illicit ID liquor in his trolly bag and standing there for a Bihar boud bus with a view to go to Bihar to to deliver the same to his design customers in Bihar for his wronggfull gain. On further interrogation he disclosed that he collect the same from one of his suppliers and came there for a Bihar bound bus and also disclosed that he is engaged such illegal business since few days. On search the above noted illicit liquor recovered from his possession which he kept conceal inside the trolly bag. On demand they failed to produce any documents in respect of carrying and possessing such illicit ID liquors recovered from his possession.

As they willfully violated the norms of Bengal Excise Act, hence, I seized the above noted illegal illicit liquor from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 22.40 hrs to 23.15 hrs under the coverage of videography executed by Somanath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri, Dist. Darjeeling. Subsequently, I arrested the above noted detained person namely Mukund Madhab (33 yrs) S/O Sudhir Kr Jha of C/O Pawan Kr Gupta of Circuit House, Barah Patther Chowk, Kashipur, PS+Dist. Samistipur, Bihar after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS after his medical examination for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Mukund Madhab (33 yrs) S/O Sudhir Kr Jha of C/O Pawan Kr Gupta of Circuit House, Barah Patther Chowk, Kashipur, PS+Dist. Samistipur, Bihar for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
