I Mr. Tattwanoshi Chakraborty son of Mr. Nityanarayan Chakraborty resident of Siliguri Baghatan colony, 45/6 road. Age of 25 year want to lodge an FIR against Snatcher. I was physically assaulted by Snatcher in Channuni area at 8:20 to 8:25 pm

Dated 24th June 2025. The Snatcher followed me in Channuni; I was travelling through cycle they were travelling through Scooty, Brand Dio (white-green) colour

There was 2 young person who provoked with talking casually & suddenly attacked to me asking for all belongings I have. After multiple alerts I gave they suddenly took out a dagger knife & stabbed my left hand & tried to attempt murder

They snatched my purse where all my imp docs were there (Adhar card, pan card, debit card, cash of Rs. 2500)

I tried to stop them and screamed for help. All local people came there they immediately left the spot.

I request you to take necessary action against this & provide justice.
