resident of Naya Nagar, PO - Hatighisa Dist -
Darjeeling WB. I would like to inform you that on
21st June 2025 at about 10:00 pm to 10:30 pm
my son namely Kuldeep Minj, aged about 27 years
with his friend namely Subesh Minj were going
to Medical college Hospital on a scooter being no.
WB 74 BP 8907 from Narailbari. My son was
riding the scooter and both were wearing helmets.
That it was heavily raining at that time and
near the Shivmandir flyover a dumper (truck)
being No. WB73E7186 was coming from wrong
side on national Highway due to his rash and
negligent driving, it hit my son (scooter's) front side
badly. Due to his negligent my son is admitted
in the Hospital ^{namely CAREW CARE Matigara,} and he is in critical situation and
the scooter has damaged badly because of the accident.
