Sub: FIR against theft incident happened at the campus of Matigara Milk Plant running by Mother Dairy Calcutta, an Organisation under ARD Department, Government of W.B.

Dear Sir,

It may kindly be noted that on regular basis, a gang of miscreants are entering into the Premises of Mother Dairy Calcutta. Matigara unit situated on Khaprail Road by breaking the doors of different rooms and taking away good numbers of costly equipments every day from Refrigeration department, Plant Building and different sections when no production is going on, mainly during night. Such incident also happened in last night (23.06.2025). Refrigeration unit condensing section water pump is missing and noticed today morning, resulted entire plant is shutdown.

Kindly note that this time the theft happened from our main Refrigeration unit and it is most dangerous for the plant. Any time an accidental damage may also happen apart from disruption of production also public health most of the pipeline is ammonia loaded any stolen time any ammonia line leakage can endanger the thief's life also local public life.

We would therefore request your good office to take appropriate measure against the miscreants & deployment of night patrolling to prevent the theft incidents as well as to save the Government property, as Mother Dairy Calcutta, Matigara unit is an organization under Animal Resources Development Department, Government of W.B.

Please treat this letter as FIR/GD against the aforesaid incident and apprehension for burglary of Government properties.
