Sir,

With due respect I, Chhaya Rani Das, W/O Brojendra Nath Das, a resident of Vill- Diglijote, PO- Sushrut Nagar, PS-Matigara, Dist- Darjeeling, WB-734012, want to inform you that today morning dated 26.06.2025, while I was out for morning walk, two unknown young men approached me from Sanyasi More in Pulsar NS bike, where one was wearing a helmet while the other was bare head, and snatched my gold chain near Doctor's Zone at 6:08 am. I tried to get hold of them but they pushed me and ran away with their motorcycle towards Durgamandir. I fell down and got injured in several places in my body. Later I got treated at NBMC Hospital. The gold chain was approx 2.5 bhor.

Therefore, I kindly request you to look into the matter for necessary action please.
