I, Ruchi Singhal Agarwal, w/o Sri Ayush Agarwal, resident of
Uttarayan Township, Block-D10, House No. 11, P.S. Matigara, Dist. Darjeeling.
would like to inform you that today I had sent a detailed email to
the Matigara P.S. and Commissioner of Police.

The driver Prayas Chettri upon the instruction of my mother-in-law
namely Kanta Agarwal had purposefully cut the wires of my camera.
Today at around 7-7.30 PM 2 persons who I had called to fix my camera
to the house when all of a sudden without any provocation my mother-in-law
namely Kanta Agarwal pulled me from behind grabbing my hands and
thereafter pushed me very hard and pressed my neck and strangled
me with an attempt to kill me due to which I was taken to Netaji
Subhas Hospital and developed problems in breathing and severe neck pain.
My mother-in-law has threatened me not to allow me to enter the house,
abused me with filthy words and further threatened to kill me. The entire
incident is recorded in the CCTV camera present there. I am in a
complete state of shock and acute distress.

I therefore request you to investigate the matter and book the
culprit namely Kanta Agarwal in accordance with the appropriate provisions
of criminal law & oblige.

Further I have enclosed the copy of the medical documents
for your reference of Neotia General Hospital of Dt. 25/06/2014.
