Sir

In producing herewith following four arrested accused persons namely (1) Raju Singh @ Kaley-22yrs s/o Mahendra Singh of Limbu busty, near Radhakrishna mandir, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Abhishek Adhikary-23yrs s/o Mukul Adhikary of North Ektiasal, Khai Khai bazaar, PS Bhaktinagar Dist Jalpaiguri (3) Shekhar Rai-40yrs s/o Lt Kashiram Rai of Gandhinagar, Manpuri busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri and (4) Rahul Mondal-20yrs s/o Raju Mondal of Sahani busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made sharp cutting chopper with wooden butt measuring approx 12 ½ inches recovered from the exclusive and Conscious possession of Raju Singh @ Kaley
- 2) One iron made sharp cutting knife with wooden butt measuring approx 8 ½ inches recovered from the exclusive and Conscious possession of Sekhar Rai.
- 3) One iron rod measuring approx 03 feet 4 inches recovered from the exclusive and Conscious possession of Rahul Mondal.
- 4) One screw driver measuring approx 9 inch recovered from the exclusive and Conscious possession Abhishek Adhikary.

I, SI Srimanta Chatterjee s/o Debi Prasad Chatterjee of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 26.06.2025 at 00:05 hrs received a specific source information that 10/11 miscreants have assembled at the P.C Mittal bus stand under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No 1389 dated 26.06.2025 and as per order I along with SI Srimanta Chatterjee, SI Youel lepcha, ASI Dipak Karmakar, ASI Khagen Barman C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for P.C Mittal bus stand under Bhaktinagar PS to work out the information in hand vide GDE No-1390 dated 16.06.25.

At about 00.15 hrs we arrived at the P.C Mittal bus stand under Bhaktinagar PS as indicated by the source we noticed that 10/11 persons assembled at P.C Mittal bus stand under Bhaktinagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 7/8 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for

committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 26.06.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Raju Singh @ Kaley-22yrs s/o Mahendra Singh of Limbu busty, near Radhakrishna mandir, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Abhishek Adhikary-23yrs s/o Mukul Adhikary of North Ektiasal, Khai Khai bazaar, PS Bhaktinagar Dist Jalpaiguri (3) Shekhar Rai-40yrs s/o Lt Kashiram Rai of Gandhinagar, Manpuri busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri and (4) Rahul Mondal-20yrs s/o Raju Mondal of Sahani busty, ward no-43 PS Bhaktinagar Dist Jalpaiguri and 7/8 others also arrange for its investigation.
