I, Ranadip Mazumder, S/O:-Late Kalipada Mazumder, AE & Station Manager, Powerhouse CCC, WBSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 26.06.2025 at Kholachand Fapri, near Tribeni chowk Dist:-Jalpaiguri, which I believe warrants immediate attention and investigation. The incident involved an accident by a Hyundai Nios Sportz Car (Bearing no:- WB74 / BM5292) with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSEDCL's property and public safety.

As information received from the local residents of the accident location at 12.50 PM, Our technical team attend the spot immediately at 1:10 PM and found that 01(One) 8 Mtr PCC pole broken & damage of 0.030 mtr LT AB cable with damage of other electrical installation due to the accident with the said Car.

The total financial losses caused due to this accident are approximately Rs. 16500.00 (Sixteen Thousand Five Hundred) only.

Given the potential risks and significant financial implications, I kindly request you that a FIR be registered regarding this accident against the said Car No:- WB74 / BM5292. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSEDCL property.

This is for your kind information and further needful action please as per law.
