Subject: FIR for Brutal Physical Assault with Iron Rod over Loan Matter

Respected Sir/Madam,

I, Sayantan Tar, S/o Shri Sankar Tar, resident of Ghogomali, Ward No. 37, Siliguri, wishes to lodge a serious complaint regarding a violent and life-threatening assault that occurred on 25/06/2025, at around 9:50 pm, at Shanti Nagar, the residence of the accused.

On the said date, I approached Rittik Sannal, S/o Shri Ramendra Krishna Sannyal, to demand repayment of a loan amounting to ₹24,00,000 (Twenty-Four Lakhs Rupees) that he had taken from me. Instead of responding respectfully, the accused brutally attacked me with an iron rod, without any provocation.

The assault was deliberate and extremely violent, targeting my head and body. I sustained serious injuries and required urgent medical treatment. The intention behind the attack was clearly to cause grievous harm and intimidate me into silence regarding the loan matter. This has not only resulted in physical trauma but also caused immense psychological distress.

I request you to register this as an FIR under the following sections of the Indian Penal Code:

Section 323 – Voluntarily causing hurt

Section 324 – Causing hurt by dangerous weapons or means

Section 325 – Voluntarily causing grievous hurt

Section 307 – Attempt to murder

Section 506 – Criminal intimidation

I am ready to cooperate fully with the investigation and provide medical reports, witness details, and any other evidence required.

I urge you to take immediate and strict legal action against Rittik Sannal, S/o Ramendra Krishna Sannyal, and ensure justice is delivered.
