Respected Sir,

With due respect I, Smt. Preeti Kumari Jha, Wife of Sri. Nitesh Kumar Roy, D/o. Sri. Ajay Kumar Jha, presently residing at Sarojini Pally, Limbu Busty, Near Pradhan Gym, P.O. Salugarah, P.S. Bhaktinagar, Dist. Jalpaiguri, W.B. 734008, beg to state that I have entered into marriage with Sri. Nitesh Kumar Roy, Son of Sri. Ram Binod Roy, resident of Batho, Block Benipur, P.S. Bahera, Dist. Darbhanga, Bihar-847233 which was solemnized on 08/02/2023 according to Hindu Rites and Customs in the house of my father situated at Vill. & P.O. Jariso, P.S. Bahera, Dist. Darbhanga, Bihar. At the time of the marriage, my father had given some gold and silver ornaments, furniture's, utensils, clothes etc. to me as per demand of my husband and his family members and my father was also compelled to pay a sum of Rs. 1,75,000/- in cash to my husband and one motorcycle as per their demands.

After marriage, my husband took me to his house and we have started to live together as wife and husband. Thereafter till the one year from the date of marriage, all were okay though on some occasions my husband used to ask my father to give him some amount and my father also paid some amount about 25 thousand to him. After expiry of one year i.e. since January 2024, my husband along with his parents, sister-in-law Nandani Jha and her husband all along have increased their demand of dowry by asking me to bring money from my paternal house, they used to misbehave with me and they did not provide food and daily needs to me and always abused me with filthy languages. In all times, I have tried to adjust with my husband and in-laws but I have failed due to continuous torture by them. Thereafter, finding no other alternative in the month of February 2024, my father has given a sum of Rs.4,00,000/- to my husband by sending the amount to his bank account. In spite of receiving such amount, my husband and his family members have demanded more amount from my father and on demand of such amount, on 01/03/2024, my husband, father-in-law and mother-in-law have assaulted me with wooden materials where I sustained greivous injury but they even did not took me to the Doctor. On the same day and within further 20 days, my father again sent a sum of Rs.5,00,000/- to my husband under such commpelling circumstances and also to save my life.

Subsequently, my husband took me to his working place at State No.1, Ambedkar Nagar, 33 FT Road, Gyaspura, Near Adarsh School, Ludhiana where we have started to

reside as husband and wife. After reaching at Ludhiana, I found that my sister-in-law and her husband namely Nandani Jha and Narayan Jha are also residing thereon. My husband used to return back at midnight in a drunken condition and after finding the same, I have told him not to take wine/alcohol on everyday, my husband used to torture upon me by both physically and mentally, but with a hope that he will rectify himself, I used to tolerate the same. At the instigation of my in-laws, my husband along with my sister-in-law Nandani Jha used to demand dowry from my father. On 26/06/2024, my father was again compelled to give 25 thousand rupees to my husband. Though my father used to send amount frequently but inspite of that my husband, sister-in-law Nandani Jha and her husband Narayan Jha used to beat me, abused me without any reasonable cause. Lastly on 15/06/2025 at night, my husband while in drunken condition in presence of her sister has beaten me with iron made bala and pushed me to the bed in anger that causes pain in my head and lips got swollen and bleeding. On the next morning i.e. on 16/06/2025, I have left the house of my husband in a single cloth and called my father, and my father has brought me to his present residence at Sarojini Pally, Limbu Busty, Near Pradhan Gym, P.O. Salugarah, P.S. Bhaktinagar, Dist. Jalpaiguri where my father, mother and sister are residing due to the job of my father. Even after reaching here in the residence of my father, my husband and in-laws continuously threatened me over telephone with dire consequences. On 20/06/2025, my husband came to the house of my father mentioned above at Siliguri and started to abuse me in filthy languages and demanded huge amount from my father.

So, I request you to take necessary legal action against (1) Sri. Nitesh Kumar Roy (my husband), Son of Sri. Ram Binod Roy, resident of Batho, Block Benipur, P.S. Bahera, Dist. Darbhanga, Bihar-847233, presently residing at State No.1, Ambedkar Nagar, 33 FT Road, Gyaspura, Near Adarsh School, Ludhiana, (2) Sri. Ram Binod Roy(father-in-law), (3) Smt. Parmila Devi (Mother-in-law), both are resident of Batho, Block Benipur, P.S. Bahera, Dist. Darbhanga, Bihar-847233 (4) Narayan Jha (Brother-in-law), and (5) Smt. Nandani Jha (Sister-in-law), W/o. Narayan Jha, both are residing at State No.1, Ambedkar Nagar, 33 FT Road, Gyaspura, Near Adarsh School, Ludhiana. And for this kindness, I shall much oblige to you
