With reference to the above mentioned subject I, Soumen Basu s/o Late Surya Kumar Basu resident of Road No-4, Shaktigarh PO Siliguri Bazar District Jalpaiguri would like to draw your kind attention in this matter that I am looking after the progress of the above mentioned work on behalf of the Company.

Sir, yesterday (25.06.2025) about 8.30pm while working with JCB machine at Road suddenly one street dog comes suddenly under our JCB and that dog died at spot in that accident.

Suddenly we found that some miscreants named 1. Kunal Chakraborty s/o unknown to us, 2. Sonali Chakraborty d/o unknown to us, 3. Ranjita Sharma d/o unknown to us all resident of Nabagram Pipe Line, Ward No 33 under SMC District Jalpaiguri has brutally physically abused our JCB driver and our others workers at the spot with bamboo sticks and with iron rods even they have stopped our ongoing aforesaid works also they have closed the road at our on going aforesaid work site. Our JCB Driver and others labors are later rescued by help of police team of NJP PS. The above three persons have threatened our workers to not to allow to restart our ongoing site any more.

Sir, all of our workers are feeling unsafe to work at our aforesaid site in this situation.

Sir, I request you to kindly look into this matter and kindly expedite so that we can restart our on going aforesaid work at the earliest.
