I ASI Manoj Majumder of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 05/06 persons to the effect that on the night 28.06.25 at 01:45 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Suryasen Colony, Block E under NJP PS with a view to commit dacoit. Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 1398 dated. 28.06.25. As per your kind direction at 01:55 hrs myself along with C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 1399 dated. 28.06.25 for Suryasen Colony, Block E to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 02.10 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the mentioned place. When we reached nearby of Suryasen Colony, Block E and found a group of 13/14 persons assembled and gossiping in a dark place as stated by the source. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from the spot. Somehow, after a hot chase we could able to apprehend the above noted eight (08) persons and the others 05/06 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoit after making full preparation in the nearby place of Suryasen Colony, Block E under NJP PS. I try to manage the independent witnesses

but due to late night I couldn't find any independent witness to be present at the time of search and seizure. Thereafter all the apprehended persons were searched and I found and recovered the above noted articles from their possession and seized the same under proper seizure list duly signed by them and the process of search and seizure has been recorded in audio-video means as per the provision of law. The seizure was made between 02:32 hrs to 02:50 hrs. Accordingly I arrested the above noted accused persons u/s 35 BNSS under proper memo of arrest and ground of arrest is duly communicated with them.

So I pray before yourself that a specific case may kindly be started against the accused persons namely 1) Akash Sahani (24) S/o Bindi Sahani of Nabagram, PS- New Jalpaiguri, Dist -Jalpaiguri 2) Surja Roy (19) S/o Rajesh Roy of Shantipara, PS- New Jalpaiguri, Dist -Jalpaiguri 3) Biki Barman (27) S/o Bhopal Barman Of Shantipara, PS- New Jalpaiguri, Dist -Jalpaiguri 4) Debu Roy (45) S/o Late Jiten Roy of Suryasen Colony, PS- New Jalpaiguri, Dist -Jalpaiguri 5) Keshob Ghosh (35) S/O- Paritosh Ghosh of Suryasen Colony, PS- New Jalpaiguri, Dist -Jalpaiguri 6) Bharat Barman (35) S/O- Late Sambhu Barman of Shantipara, PS- New Jalpaiguri, Dist -Jalpaiguri 7) Md. 
