Kalimpong, Pin. 734503 would like to inform you that on 17/01/2023 I married with one person namely **Sri Kamal Kant** Bhagat, S/o. Late Chuman Bhagat, R/o. Rail Colony, Bagdogra, Dumriguri Dakshin Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, Pin. 734014 and said marriage was duly registered before the office of the registrar general of marriages Under section 13 of Act XLIII OF 1994 and on 22/02/2023 one social marriage also solemnized between me and my husband at my parental address as per Hindu Rites and Customs and at the time of marriage our parents and well wishers are present and thereafter we started to live together as a Husband and wife at the residence of my husband. This is right place to mention here that at the time of marriage as per demand of my husband and my mother —in- Law namely **Smt.** Parbati Devi my parents gave them a sum of **Rs.50,000/- (Rupees Fifty Thousand) Only** by cash and one Gold chain, one Finger Ring, One Neckless, Two Pair Ear Rings and other gold ornaments and also other house hold articles like Khat, Drsesing table Box Khat, Tea Table etc.

It is pertinent to mention here that after few days of my marriage I notice that his behaviour day by day changed in respect of me and he always came to home at late night with dunked condition and after coming to home my husband and my mother-in-law make criminal conspiracy and after that both of them started to pressured me to bring a sum of Rs.1,00,000/-(Rupess One Lac) Only from my parental house and when I denied to do the same at that time they all of them became ferocious and started to abused me and also they all of them physically and mentally tortured me.

It is also important to mention here that our marriage was fix in the month of August, 2022 and after that me and my husband regularly basis contact with each other over telephone and during that period also by giving some silly issues / business purpose he always took money from me and my parents and me and my parents in different dates send him total a sum of Rs. 4,91,800/- (Rupees Four Lacs Ninety One Thousand and Eight Hundred) only (All the Transactions made by me and my parents from our accounts and I annexure the bank statement with this complaint).

It is pertinent to mention here that after 2 (Two) Days of my marriage I noticed that my husband after came to home with drunk condition, he always busy on over phone at late night and continuously chat in social media platform and when I asked him why he busy on over phone and with whom and he chat on social media site at that time he told me that he busy with his friends but after few days when I searched his phone during that time I saw that my husband has an illicit relationship with a woman namely Anita Thakur and said woman resides in the same locality of my husband and after that I asked him about the said lady but that time he told me that he don't have any relationship with that lady and after that he became ferocious and started to assaulted me with fist and blows and thereafter no other alternative

way I informed all the incidents to my mother-in-law but she did not pay any heed to my said information and ultimately no other alternative way I informed all the incidents to my parents and during that period my husband each and every day contact with the aforesaid lady and due to said reason my husband every day assaulted me and his mother supported the same and ultimately in the end of month of May, 2023 I caught my husband when he made conversation with that lady at that time he became feroclous and started to assaulted me with fist and blows in presence of my mother-in-law but my mother-in-law did not rescued me and both of them thrown me out of my matrimonial house and thereafter with the mercy of god or with the help of my parents some well wishers came to the spot and after that I reached at my parental house and take shelter there.

It is also important to mention here that after take shelter at my parental house I reside there almost 17 Months and during that period my husband and my mother-in-law did not contact with me and did not make any attempt to take me back at matrimonial house and at that time me and my family members several times tried to contact with them but they did not pay any heed and also do not pickup my phone call and during that period my husband did not provide any sort of maintenance and also did not fulfil my essential needs but after expiry of 17 Months due to interfere of my parents and well wishers one meeting has been held at my parental house and during that meeting he told me that he never contact with the aforesaid lady and also give me assurance that he will lead a happy conjugal life with me and after said assurance I returned back at my matrimonial house on 21/10/2024.

This is right place to mention here that after return back to my matrimonial house I thought that my husband and my mother-in-law will change their behaviour in respect of me but all are in vain because this time they increased their torture upon me and always at late night both of the persons made tremendous pressured upon me to bring of Rs. 5,00,000/-(Rupees Five Lacs) only from my parental house but when I denied the same at that time they both of them assaulted me with fist and blows and also used slang languages in respect of my parents but I tolerated all those inhuman torture of them with a hope that one day they will change but such day never come to my life. Ultimately in the month of January, 2025 when my husband was sleeping at the bed room at that time I took his mobile phone and after that I saw that my husband continuously contact with that lady and I also saw some objectionable conversation between them (I captured all the phone calls details and whatapp conversation between them in my mobile phone I annexure said phone calls details and conversation with this Complaint) after that I immediately contact with the aforesaid lady on over telephone at that time she very badly threatened me and also told me that if me or my parents interfere into their personal life then she will kill me and during that time she also told me that they will marry within shortly and after listening the same I immediately informed the incident to my mother-in-law but this time also she supported her son and suggested me to adjust with her son after that I asked the aforesaid matter to my husband during that time also he assaulted me as per instruction of his mother. Ultimately on 16/01/2025 my husband came to home at late night with drunk condition and at time I was sleeping at my bed room and taking advantage of the same my husband and mother-in-law contact with the aforesaid lady over telephone and thereafter they made criminal conspiracy and as per instruction of the aforesaid lady my husband and my mother-in-law silently entered at my bed room and with an intention to kill me they with the he Scanned by Camera Scanner

Therefore, I request you be pleased to drawn your kind attention in respect of my above noted written complaint and also be pleased to take necessary legal actions against them as early as possible.
