I **Smt Shreyasi Saha**, Wife of Sri Soumendra Nath Lahiri, Daughter of Sri Santosh Saha, resident of Bimal Sinha Sarani, Hakimpara, Ward No.12 of Siliguri Municipal Corporation, Post Office & Police Station-Siliguri, District-Darjeeling, Pin-734001, West Bengal, do hereby inform you that my husband Sri Soumendra Nath Lahiri married me on 29.01.2020 as per Hindu Rituals and customs at Soubhagya Palace, Udham Singh Sarani,, Punjabi Para, P.O & P.S-Siliguri, District-Darjeeling, Pin-734001 in presence of friends, kiths, kins and relatives of both the sides.  
It is pertinent to mention that prior to my social marriage a registered marriage was solemnized between me and my husband on 03.11.2019 in accordance to the Special Marriage Act 1954 before the Special Marriage registrar for Siliguri Police Station jurisdiction namely Sri Bijoy Kumar Ghosh, the said marriage was out of love and affair.  
Subsequently the reception party (boubhat) was held at Vivekananda Bhawan, Barobhisha, District-Alipurduar on 03.02.2020.

After boubhat I along with my husband stayed at my husband's house at barobhisha wherein at the very nascent stage of marriage he expressed his dissatisfaction over the quantity and quality of jewellery received from my parents and relatives, he also told me that he is a successful software engineer and he had better opportunities and options and he is dumb for not opting them.

Thereafter almost after two weeks my husband took me to Kolkata i.e. his place of employment and at that relevant time he was posted at TCS (Tata Consultancy Services) Rajarhat, New Town, we used to stay in a rented accommodation there at Sapoorji Complex.

At Kolkata he started showing his true colours he used to beat me with fists and blows and moreover he did not allow me to visit the doctor so that I cannot collect the injury report, he used to confine me to the apartment and take away my mobile phone along with him. He did not take me to his office functions and social gatherings and used to mentally torture me by confining me solitarily to the apartment.

After few days lockdown started and my husband sent me to my paternal house at Siliguri and he went to his house at Barobhisha and started to work from home, whenever he visited my paternal house at Siliguri (Bimal Sinha Sarani, Hakimpura, Ward No.12 of Siliguri Municipal Corporation, Post Office & Police Station-Siliguri, District-Darjeeling, Pin-734001) he used to physically abuse (beat) me with fists and blows in presence of my parents who felt helpless seeing his aggressiveness but expected everything would change with passage of time.

He told me to stay along with my parents till the lockdown gets over and he shall bring me back after the lockdown is lifted but I still went to my matrimonial house during the lockdown tenure but he always insisted me to return back.

He took my password of all social sites such as facebook, instagram, e-mail's as he used to disbelief me.

Thereafter my husband planned to move to on site at Australia and he told me that he has different future plans and he cannot stay with me and hence he will not take me to Australia, thereafter by the intervention of my parents my husband finally agreed to take me to Australia.

After shifting to Australia his behaviour deteriorated and he used to treat me as the maid servant but I was not aggrieved as I was doing work as a home maker but he started frequent quarrels with me and he used to punch me on my face and he used to slap me, kick me.

It is pertinent to mention that on multiple times blood oozed out of my nose and lips as a result of the blows which my husband inflicted upon me.

He never ever allowed me to visit the doctor as his work visa would get cancelled if the Australian authorities would know about the inhumane treatment of Soumendra Nath Lahiri.

He prohibited me to attend social gatherings and carry out my vocational activities,

He did not allow me to talk to anyone as I may tell them about the physical and mental torture which I was suffering from as he did not want that anyone to be acquainted with the criminal activities which he used to commit upon me.

Thereafter he forcefully sent me to Kolkata on 06.01.2024 and subsequently he blocked me and prior to blocking me he told me that my dependant visa has been cancelled and I can't go to Australia anymore.

My parents did communicate with him but he used to threaten my parents with dire consequences if my parents insisted him to resume my conjugal life with him.

He also told my parents that he will only give mutual divorce without alimony and he shall remarry and if I do not agree to his proposal then he shall kill me.

Thereafter being constrained I through my Ld Advocate did send him a notice for paying a permanent alimony and thereafter file a mutual divorce.

Notices were sent through both speed post and whatsapp and after receipt of the notice Soumendra Nath Lahiri refused to pay permanent alimony even though he earns a handsome salary and is settled at Australia.

I being tired of his cruelty and torture succumbed to his ill treatment and told him on whatsapp call that I am ready for mutual divorce without alimony but even though he refused to come to India and told me that he has Barristers and Solicitors at Australia who has instructed him to carry out a recorded video conference with me and my lawyer in which I have to carry out a trial and prove the allegations which were written in the legal notice.

Yesterday at about 10:57 A.M he did whatsapp me and told me to clarify my claim.

I called him on whatsapp 11:59 A.M and wrote to me that he is in a meeting and he called me back at 01:12 p.m and I told him that whether he wants to stay with me or not thereafter he said no and he also denied to agree to mutual divorce without alimony and he also threatened to kill me.


Moreover he told me that he stays in Australia and hence I cannot do anything to him and soon he will get Australian citizenship and it will be beyond the Indian Courts to take action against him.

I therefore request your good office to look into the matter and take necessary action as per the law of the land against my husband Sri Soumendra Nath Lahiri for torturing me both physically and mentally and for trying to evade the Indian authorities for the crimes he have committed and for threatening me with murder.

Please treat this as very urgent and do the needful.
