Sub-written complaint against 1. Pinak Dey s/o Paritosh Dey 2. Paritosh Dey son of not known 3. Tamali Dey w/o Paritosh day all are resident of Atul prasad Sarani near Sunanda sweets hakim para-P.O. & P.S Siliguri dist. Darjeeling.

Sir,

I, SMT. PAMELA CHAKRABORTY, W/o Pinak Dey, D/o, Prasanta Kumar Chakraborty, resident of Atul Prasad Sarani near Sunanda sweets Hakim Para, P.O & P.S Siliguri Dist. Darjeeling, presently residing at Pradhan Nagar, ward no 02, P.O. & P.S Pradhan Nagar Siliguri Dist. Darjeeling .would like to draw your kind attention to the following effect that on 25/05/2023 above noted Pinak Dey i.e., SL NO. 1 took me in his house i.e., at Atul prasad Sarani near Sunanda sweets Hakim Para P.O & P.S Siliguri Dist. Darjeeling wherein his parents i.e., Sl. No. 2 & 3 alongwith Pinak Dey created pressure upon me to marry Sl. No-1 otherwise he will commit suicide, I several times requested them to give me time to convince my parents but they are too adamant, it is to be noted that I had love affair with the Sl. No. 1 for the last 9 to 10 years. Ultimately, I became emotional and also frightened and agreed to marry Sl. No. 1 and our marriage was solemnized at Bidhan Market Kali Bari. P.O. & P.S. Siliguri, Dist.- Darjeeling on 25/05/2023. Thereafter my parents came to our matrimonial house after 2 days to meet with me and tried to take back me in my parental house but the aforesaid persons misbehaved with them and not allowed me to go with them and also created pressure upon me to not contact with my parents but surprisingly in the month of September, 2023 the aforesaid persons asked me to tell my parents to arrange a social marriage to save their social prestige and the aforesaid persons also inflicted mental torture upon me to bring good quantity of gold ornaments alongwith Rs. 10,00,000/- for establishment of new business of SL. No. 1, finding no other alternatives I being a destitute woman asked my parents to arrange a wedding ceremony and give me good quantity of gold ornaments alongwith Rs. 10,00,000/-, thereafter my parents arranged wedding ceremony, thereafter in 8th of October 2023 my parents came in my matrimonial house alongwith my other relatives and for blessing ceremony wherein my parents gave to my husband i.e. SL. No.1 one gold chain, one diamond finger ring and wearing apparels for my husband and his parents and on 16/10/2023 I along with my husband and father in law and mother in law and relatives of my husband went to my matrimonial house wherein my parents gave me one pair of Gold Bangles (48.790 grams), one Gold Necklace (29.190 grams), one Gold Chain (12.540 grams), one Gold Stud (9.190 grams), one female Gold Ring (6.510 grams), one gold Gents Ring (4.036 grams), one Gold Pearl Mantasha (10.270 grams), one Gold Ratnachur (14.020 grams), one Ladies Gold Ring (1.536 grams), one diamond Pendent with Chain (2.770 grams). And after taking lunch and dinner we left for our matrimonial house. But after all these my husband alongwith his parents were not satisfied at all and they started to demand more gold ornaments and cash money from my parental house. within few days I noticed the behavioral changes in my husband and his family members at the initial stage therefore I was continuously subjected to humiliation, neglection and degrading treatment. Over the time my husband confronted me and clearly stated that he is not able to

take my responsibility either financially or as a husband if I am not able to bring the demand of him or his family members. But I did not disclose the aforesaid humiliation to my parents because my marriage was on my own sweet will, however on 11th February 2022 wedding

ceremony was held at Siliguri Deokota Sangha, SNT Road Pradhan Nagar, Siliguri by my parents. It is to noted that our marriage was registered on 30/01/2024 under Hindu Marriage Act being certificate No. WB327004000101000021194-2023-146192 before the marriage officer Sarmistha Roy at Meghnath Sarani, Hakim Para, near Vivekananda School, P.O. & P.S. Siliguri. Thereafter my husband alongwith my in laws used to demean my family and me whenever they used to get the opportunity. My personal freedom was suppressed and I was not being able to make any independent decisions or had the freedom to communicate with my own family relatives and friends. I was also forced to bear the monthly expenses because I was working in a private school as a school teacher. My husband also took money from me for his personal use which also included the expenses for health insurance for both of us and never returned the money back to me even the S.L No.1 snatched the ATM Card from me. I have constantly been harassed for money from my husband and in laws. Other than this my husband used to frequently get intoxicated and take substances and engaged in verbal abuse, and tortured me mentally and verbally, he used to threaten me and physically abused me late at night. These incidents used to occur regularly and I was subjected to deep fear, anxiety attacks and mental trauma. Ultimately on 19/05/2024 S.L.No.1 inflicted tremendous torture upon me physical and mental at late night out of fear I cried for my life but S.L.No.2 and 3 never tried to save me from the hands of S.L.No1 somehow I rescued myself and confined me in a bathroom and for the whole night I stayed therein, next morning my in laws were hurling filthy languages towards me and directed me to go to my parental house and to bring Rs 10,00,000/- for business set up of S.L.No1 otherwise you immediately leave their house and stay in a rented house alongwith your husband i.e. S.L.No.1 finding no other alternative I called my parents through my phone on the same day ultimately they came and took me with them but the aforesaid in laws restricted me to take my gold ornaments and other valuable articles because those articles were in sole custody of the S.L. No.2 and since then I am living with my parents and the aforesaid persons never tried to take me back in my matrimonial home to save my marital tie. I several times tried to contact with them on 20/06/2025 I myself visited my matrimonial home to bring my gold ornaments at about 3 PM but my father was standing nearby locality but the aforesaid S.L.No.1 restrained me to enter into my room and denied to give me my own gold ornaments and asking me to take the same through court. So, I came out from the main door of my matrimonial home with a great shock. Some unintentional delay is appeared to lodge this complaint due to my mental pain and agony because I tried to save my marital tie.

In view of above you are requested to look into the matter and take necessary actions against the aforesaid persons as per law.
