Sir,

With due respect and humble submission I ASI Pijush Sarkar of Uttorayon OP, Under Matigara P.S do hereby lodge this written complaint to the effect that today on 28.06.25 I was deputed to perform special MC mobile duty along with force, since 18.05hrs vide Uttorayon OP C.C. No. 47(06), Dated 28.06.25 and Uttorayon OP. GDE No. 505 Dated -28.06.25 in course of said special MC mobile duty I received source information that one Dumper(Truck) is coming from City Centre More towards Uttorayon Township under Uttorayon OP loaded with river bed material which were procured clandestinely. On receipt of such information, I informed the matter to O/C Uttorayon OP over phone and as per his kind direction myself along with force rushed at Uttorayon Township under Uttorayon OP and found one Dumper(Truck) bearing Regn. No. WB-73D-3447 loaded with river bed materials managed to detain at Uttorayon Township near Tri Junction under Uttorayon OP. On seeing the Police team the driver of the vehicle tried to flee away but somehow we apprehended him. On demand he could not produce any valid documents in support of said river bed materials. It is crystal clear that the driver/owner of the Dumper (Truck) bearing Regn. No. WB-73D-3447 procured the loaded river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle Dumper (Truck) bearing Regn. No. WB-73D-3447 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at Matigara P.S and arrested the driver namely Durlab Biswas S/o Santosh Biswas of Balason Colony, Ps. Matigara, Dist. Darjeeling. The seizure was made in between 20.55hrs to 21.01hrs on 28.06.25

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Dumper (Truck) bearing Regn. No. WB-73D-3447 and arrange for its investigation.
