It has caused a Confusion, anxiety and unrest in my self being. The Agreement for Sale of Land was done in my absence, without letting me to know all about its details and the purpose and cheating me as well.
5. This is very serious Crime and I would request you to immediately file an F.I.R under the relevant sections of Law against Sri Subrata Chakraborty who has forged my Signatures and Sri Atanu Sinha who has also participated and played his role in this serious Crime.
