I Hajendra Sharma S/o Lt Sharan K. Sharma
resident of Pradhan Nagar Sai Mary Road Siliguri
Junction.

I do hereby bring to your kind attention that on
28th June 2025 Mister Krishna K. Sharma his wife
Rita Sharma and son Satyendra Sharma have
forcefully trying to construct a wall which is
completely un-constituted and illegitimate and have
booked abuses and given death threat to my family.

Sir a death threat falls under the category of
criminal intimidation, which is defined under
Section 503 of the Indian Penal Code. The punishment
for Criminal Intimidation, including threats to
cause death, is outlined in Section 506 of the
Indian Penal Code.

I would request you to take immediate and
strict action.
