I Saugata Mukherjee, Age 51, Present Address – Elegant Apartment, Jyotinagar, Ward No 41, Dist- Jalpaiguri, Pin- 734001 would like to draw your kind attention on the following effect that most often I visited the Rox Bar and the staffs of that place are very well known to me, few days ago I went to that Bar and at the time of leaving that place the above named accused person informed me that my bill amount is Rs. 11000/- then I told him that there is some confusion about this bill amount and also requested him to check it again, then after checking he agreed and replied that some mistake has been done by the accountant and the exact bill amount is Rs-9000/- then I requested them please check the CCTV camera and informed me then I will clear the entire the bill, and at that time he agreed with it and asked me to leave .

But on 27-6-2025 at about 3.30 p.m. when I return from work the above mentioned accused person stopped me at Sastri Nagar , Radha Krishna complex and demand me the due bill amount and when I try to convince him and told him that I will pay entire bill amount but not here but at the bar, he without any reason started using filthy languages upon me and when I defend him, he without any reason started beating me here and there and not only that he kicked me on my chest as a result I fall down and sustain injury on my chest, then he took out a sharp knife and demanding my wallet otherwise he will kill me, finding no other alternative I hand over my wallet and he took Rs. 14700/- from my wallet and also snatched gold chain from my neck and when I started shouting, he fled away. Then some local people rescue me and took me to the Siliguri District Hospital and there my treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities and give relief to me as because I am very much afraid by thinking that he is a dangerous person and can do anything with me at anytime.
