With due respect and humble submission, I beg to report before you that I, ASI Khagen Barman s/o Noni Barman of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against following persons to the effect that on 29.06.25 at about 02.20 hrs while performing PS night mobile van duty had been to Firangee Restaurant cum Bar situated at Sevoke road under Bhaktinagar PS for routine visit of closing Bar in time at 02.00hrs as per order of The Superintendant of Excise, Jalpaiguri vide order no-1425/E Dated 28.06.25 and found that the Bar was running in that time after violation of permission by Excise department, Govt of West Bengal, The Bar was ruining up to 02.45AM after violating the Govt order. I checked the CC Camera footage where I found the Bar was ruining up to 02.45AM after violating the Govt order.

During enquiry it came to learn that one (1) Ankit Agarwal-41yrs s/o Rajendra Agarwal of Birpara Bazar, PS Birpara, Dist Alipurduar and (2) Ankur Agarwal s/o Lt Ajay Kumar Agarwal of Maynaguri Bazar PS Maynaguri Dist Jalpaiguri ruining that bar and Pab after violating gov order. I tried to serve notice u/s 35(3) BNSS but he refused to accept the notice and showed unwillingness to close the bar. Finding no other alternative, I arrested the above noted persons to enforce the order passed by Govt. authorities after issuing arrest memo and ground of arrest. I also video graphed the scene with my mobile camera.

I therefore pray that a specific case may kindly be initiated against the accused persons viz. (1) Ankit Agarwal-41yrs s/o Rajendra Agarwal of Birpara Bazar, PS Birpara, Dist Alipurduar and (2) Ankur Agarwal s/o Lt Ajay Kumar Agarwal of Maynaguri Bazar PS Maynaguri Dist Jalpaiguri under proper sections of law.
