Sir,

In producing herewith one arrested accused person namely Jakir hussain (54years) S/O Lt Abdul Latif of Salugara Santipara, ward no 42, PS Bhaktinagar District Jalpaiguri along with following seized article :

- i) One piece of new pattern India Army Combat uniform measuring 11 (Eleven) meter.
 - ii) One piece of new pattern India Army Combat uniform measuring 3 (three) meter.
 - iii) One piece of new pattern India Army Combat uniform measuring 1.5 (one and half) meter.
 - iv) One piece of new pattern India Army Combat uniform measuring 1 (one) meter.
- In total 15.5 meter new pattern India Army Combat uniform.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 29/06/25 at about 16.55hrs Military Intelligence Sukna came at PS and submitted a written complaint that one person is illegally selling Fabric of new pattern combat uniform of Indian Army, the fact has been noted in Bhaktinagar PS GDE no 1588 Dated 29.06.2025. AS per the order of IC Bhaktinagar PS I along with ASI Dipak Karmakar, ASI Khagen Barman, ASI Ramesh Bhitrikothi, C/ 422 Chandan Murmu all of Bhaktinagar PS left PS for Salugara to verify the veracity of the information. After arriving there as indicated by the source we conducted raid at the shop style as "Atif Shahin Enterprises Tailor" which is located at Salugara under Bhaktinagar PS. On being searched we recovered above noted articles which are totally prohibited to sale outside of Army premises by public except army personnel. The fabrication and supply will only be made available to the troops of Indian Army through central procurement and canteen stores department. The Indian Army has obtained the requisite Intellectual Property Right (IPR) for the 'Design and Camouflaged from the office of Controller General of Patents, Design & Trademark. Thus, the owner of the shop clearly violated the order. On being asked the owner of the shop could not produce any valid papers or documents for storing and selling the said material. On further interrogation the owner of the shop confessed his guilt and stated that since long he has been dealing of storing and selling the said army uniform for his personal gain.

Further I seized the above noted articles under proper seizure list and arrested him u/s 35 of BSNSS after issuing proper memo of arrest and the communication of ground of arrest has duly been communicated to him in presence of witnesses. The whole procedure of search & Seizure was made in between 18.15hrs to 18.55hrs and recorded under proper audio visual records.

Therefore I pray before you to start a specific case against Jakir hussain(54years) S/O Lt Abdul Latif of Salugara Santipara, ward no 42, PS Bhaktinagar District Jalpaiguri under proper section of Law and arrange for its investigation.
