In producing herewith one arrested accused namely Kamal Das (M/30) S/O Late Gopal Das of Netaji Subhash Road near Dinobondhu Sporting Club, IOC Gate, Ward No. 35, PS- New Jalpaiguri, Dist- Jalpaiguri along with seized articles Viz (1) 01 white colour Bolero Pick up van bearing No. WB 73G 7427 (2) 05 blue colour plastic barrel containing approx 200 ltrs of Diesel each and (3) 01 yellow colour plastic barrel containing approx 200 ltrs of Diesel (Total approx 1200 ltrs of Diesel) (SI No 2 & 3 loaded in SI no. 1), I, SI Krishna Parja of DD SPC, Siliguri submitting complaint to the effect that today on 28.06.2025 at 11.20 hrs received a secret source information that the driver / owner of one white colour Bolero Pick up van bearing No. WB 73G 7427 fraudulently or by stolen means collected huge quantity of Diesel from NJP IOC area and will proceed towards Kharibari through Fulbari-Ghoshpukur Main Road Clandestine disposal for their wrongful gain. Accordingly, I diarised the information vide DD SPC, GDE No. 187 dated 28.06.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with Const-670 Ratan Roy, Const-686 Arup Saha and CV-150 Bikash Thakur all of DD SPC left DD office at 11.35 hrs for Fulbari-Ghoshpukur Main Road vide GDE No. 188 dated 28.06.2025 to verify the veracity of the source information.

At about 12.05 hrs we reached at Fulbari-Ghoshpukur Main Road, Gitmabari near Fulbari Toll Gate under NJP PS and At about 12.20 hrs as indicated by the source, we found the alleged vehicle bearing No. WB 73G 7427 coming from Fulbari side and accordingly we stopped the vehicle. After disclosing our identity and reason for detain of the vehicle, on question the driver of the vehicle disclosed his name and address as Kamal Das (M/30) S/O Late Gopal Das of Netaji Subhash Road near Dinobondhu Sporting Club, IOC Gate, Ward No. 35, PS- New Jalpaiguri, Dost- Jalpaiguri . In presence of witnesses namely (1) Ranjit Roy (35) S/O Late Henu Roy (2) Subash Biswas (36) S/O Lt Nibendra Biswas both of Gitmabari, near Fulbari Toll Gate, PS- NJP, Dist-Jalpaiguri we searched the vehicle and found that the vehicle is loaded with

06(six) Plastic barrel of 200 litters each and smell of Diesel is coming out from the said barrels. Thus it is strong reason to believe that the Driver/Owner of the said vehicle obtained the Diesel by fraudulent means or by stolen means. On interrogation the driver of the vehicle confessed that he along with others procured the loaded diesel in fraudulent means and will sell the same at Kharibari area illegally for their wrongful gain. On demand he could not produced any documents in r/o the procured diesel. Accordingly, I seized the Registration No. WB 73G 7427 with key and (2) vehicle bearing (six) Plastic barrel of 200 litters each contained with Diesel (Total approx 1200 litters) (Loaded in vehicle no WB 73G 7427) under proper seizure list in presence and duly signed by the witnesses . I arrested the above mentioned accused driver U/S 35 BNSS after observing all legal formalities and intimated him ground of arrest in writing. The whole process of seizure was made in between 12.25 hrs and 13.15 hrs

I therefore, request you that a specific case may kindly be started against the arrested person namely Kamal Das (M/30) S/O Late Gopal Das of Netaji Subhash Road near Dinobondhu Sporting Club, IOC Gate, Ward No. 35, PS- New Jalpaiguri, Dost- Jalpaiguri and others under proper section of law.
