Sushrut Nagar, District: Darjeeling, West Bengal -734012 currently pursuing my Bachelor Degree in B.Sc Nurshing, do hereby tender you this written information to be registered under the aforesaid mention caption:

l, from the year 2024 was in relation with one person namely : Dhiraj Kumar Singh residing at Mahua town of Bihar.

Upon false pretext of marriage we both practiced physically with each other which involves sexual relation. During the course of sexual relation without my information, permission and consent the accused had videographed those intimate sexual moments.

Suddenly, on 13th March 2025 the accused had initially contacted me with the threat for dire consequences for not actively participating with him sexually as per his demand.
