Sir/Madam,

I, Rajoshi Barman daughter of Raj Kumar Barman aged about 21 years more or less resident of Thiknikata, P.O. Sushrut Nagar, District : Darjeeling, West Bengal -734012 currently pursuing my Bachelor Degree in B.Sc Nursing, do hereby tender you this written information to be registered under the aforesaid mention caption :

I, from the year 2024 was in relation with one person namely : Dhiraj Kumar Singh residing at Mahua town of Bihar.

Upon false pretext of marriage we both practiced physically with each other which involves sexual relation. During the course of sexual relation without my information, permission and consent the accused had videographed those intimate sexual moments.

Suddenly, on 13<sup>th</sup> March 2025 the accused had initially contacted me with the threat for dire consequences for not actively participating with him sexually as per his demand. He had also threatened me that through online and different social media platforms he would leak those videos of our intimate moments which he captured without my information & knowledge when we were engaged in making physical & sexual love to each other that he captured without my permission. That on 5<sup>th</sup> June 2025 without my knowledge & permission he uploaded photos and revealed my identity. Further, on 10<sup>th</sup> June 2025 the accused had sent certain video clippings of our private intimate moments where I was in an objectionable state on my elder sister's phone.

He further threatened me that if I kept pressing over the issue of marriage and do not participate with the accused sexually as per his demand then the aforementioned private videos of our private intimate moments and my morphed images would be uploaded in all social media what so ever available.
