Sir,

In producing herewith two (02) accused persons namely (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri under arrest along with the following articles under proper seizure viz :- (i) one black colour back pack styled as "adidas" containing 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", Cough syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00 -Marked as Exhibit "A", (ii) one black colour back pack styled as "NIKE" containing 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", cough syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00 -Marked as Exhibit "B" and (iii) one mat black colour YAMAHA Motor Cycle - Model-R15 displaying Registration number WB-74-BN-9412 - Marked as Exhibit "C". I, SI Goutam Mallik S/O Late Nikhil Ranjan Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against above noted two arrested accused persons namely (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri to the effect that on 29.06.2025 at 22.15 hrs I, received a reliable specific secret source input that two persons possessing huge quantity of illegal contrabands without any valid license would come by a Motor Cycle at Regulated market under Pradhan Nagar PS, Dist.- Darjeeling to deliver the same to their designed customers.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 1699 dated 29.06.25 and I informed the matter to you in writing. Subsequently, being directed by you at about 22.25 hrs myself along with SI Bandhan Roy, ASI Biplab Kr Das, C/1413 Sujit Sarkar and C/1411 Ashok Roy all of Pradhan Nagar PS, SPC left for Regulated Market without any search warrant or authorization for search which could not be possible to obtain from a competent authority and for sudden development of a sensitive information on a Sunday night and not to afford them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar PS GDE No. 1700 dated 29.06.2025 and M.C.C. No. 1372/25 dated 29.06.25. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over telephone and requested him to come to Regulated Market with his video camera for the purpose of video graphs if required. I also directed night RT van officer ASI Tubai Roy to come to Regulated market to accompany with us. On the way, I briefed all the Police personnel properly sharing the nature of information in hand. On the way to Regulated market I requested two available independent persons namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani and (ii) Raja Sahani (26 yrs) S/O Chunchun Sahani both of Sahani Patty, Reajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present and act as witness if any search and seizure would be made upon which they agreed. I also issued notice to the above mentioned two independent witnesses.

At about 23.05 hrs, I along with the above mentioned officers and force reached at Regulated Market under Pradhan Nagar PS and after a while night RT van officer ASI Tubai Roy along with force arrived there and accompanied with us. I briefed them properly. Then, I contacted my source who stated that both the persons possessing illegal cough syrup would come to Regulated Market shortly to deliver the same to their designed customers. At around 23.15 hrs as identified by the source, we noticed that two persons with two back packs in their possessions were proceeding towards Regulated Market by a mat black colour Motor Cycle and after a while, they stopped their Motor Cycle in front Maa Jay Durga Bhandar at Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, we cordoned the place from every corner and managed to detain both of them with two back packs in their possessions and also detained their Motor Cycle. Thereafter, we disclosed our identities as Police personnel (as I along with 4/5 police personnel were in civil dress for our convenience) and informed them regarding the information in hand. On interrogation, the detained persons disclosed their identities as (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri and also disclosed that they possessed cough syrup in their bags and came there to deliver the same to their designed customers. Then, I issued notice in writing to both of them whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer which they agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and seizure. At around 23.45 hrs the above mentioned videographer namely Somnath Chatterjee came to the spot at in front Jay Maa Durga Bhandar, Regulated market. Accordingly, I issued a notice to him for video graph the entire process of search and seizure. At around 00.05 hrs on 30.06.25 you arrived at the spot in front of Jay Maa Durga Bhandar, Regulated Market under PS- Pradhan Nagar, Dist.- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to holiday of Sunday no Executive Magistrate was found and as a gazetted officer you are legally authorise to give order to search bags of the suspects.

Then, I served a notice to you for supervise the entire process of search and seizure. Then on camera, I offered both the independent witnesses and both the detained persons to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Thereafter, in presence of you and independent witnesses noted above, I searched the black colour back pack styled as "adidas" under the possession of the accused Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and recovered 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", Cough Syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00 - and the black colour back pack styled as "NIKE" under the possession of the accused Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri and recovered 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", Cough Syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00.

On demand in presence of you and independent witnesses, the detained persons namely (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri failed to produce any valid document/paper for possessing or selling such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, they confessed their guilt and stated that they procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of their suppliers for the purpose of selling the same in high rates to their designed and selected customers and also stated that they came there for the purpose of their such type of illegal business of procuring and selling "Codeine Phosphate based Cough Syrup" illegally for the last few months for their wrongful gain. On further interrogation accused Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri disclosed that he is the owner of the detained motor cycle having registration number WB-74-BN-9412.

Accordingly, I seized the said articles viz: -(i) one black colour back pack styled as "adidas" containing 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", Cough Syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00 -Marked as Exhibit "A", (ii) one black colour back pack styled as "NIKE" containing 40 (forty) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup "REXLEY-T", Cough syrup each bottle containing 100 ml i.e. total (40 bottles x 100 ml = 4000 ml), having batch No MLS25260, Mfg date 04/25, Exp date 03/27, MRP Rs 175.00 -Marked as Exhibit "B" and (iii) one mat black colour YAMAHA Motor Cycle - Model R15 displaying number plate WB-74-BN-9412 - Marked as Exhibit "C" under proper seizure list from the possession of accused (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri in presence of you and independent witnesses and obtained their signatures which are acknowledged by the accused persons. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused persons at the spot. The whole process of search, seizure and labelling were made under the coverage of video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 00.20 hrs to 01.10 hrs on 30.06.25 as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the accused persons namely (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri are involved in procuring and selling "Codeine Phosphate Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested them after observing all formalities, informing them regarding the ground of their arrest and issuing a copy of Memo of Arrest to each of them.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Gourav @ Gopi Barai (23 yrs) S/O Late Gouranga Barai of Dakshin Palash, Natun Bazar, PS- Pradhan Nagar, Dist.- Darjeeling and (ii) Manoj Roy (25 yrs) S/O Sukumar Roy of Deep Nagar, Srilanka Busty, Dakshin Palash, PS- Bhakti Nagar, Dist.- Jalpaiguri and its investigation may kindly be arranged.
