

Sir,

In producing herewith 04 accused persons namely (i) Roshan Singh (32 yrs) S/O Late Darshan Singh of Dada Bhai Colony, Check Post, PS- Bhakti Nagar, Dist. Jalpaiguri (ii) Biplab Das (35 yrs) S/O Shyam Das of Shree colony, PO+PS- Bagdogra, Dist. Darjeeling (iii) Nipen @ Nripen Roy (18 yrs) S/O Akalu Roy of Bou Bazar, PS- Bhakti Nagar, Dist. Jalpaiguri and (iv) Bishal Routh (28 yrs) S/O Late Laxman Routh of Dharam Nagar, Coliepara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeleing under arrest along with the following seizure articles viz :- (i) one sharp cutting weapon locally called as "Hasua" measuring approx approx 25 inches in length including its approx 7 inches wooden butt (ii) one iron made insrtuement basically using for breaking lock measuring approx 17 inches in length (iii) One iron made weapon locally called as "Bhojali" measuring approx 17 inches in length including its approx 6 inches wooden butt (iv) One sharp cutting weapon locally called as "Hakshow blade" measuring approx 12 inches in length approx 19 inches in length including its 4 inches wooden butt (v) One iron made instruments called as "Plush (vi) one iron made hammer measuring approx 13 inches in length (vii) one plastic made torch light and one multi colour nylon bag. I ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 07/08 unknown miscreants who involve in this crime to the effect that on 30.06.2025 at 03.30 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled near Darjeeling More under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparation for committing Dacoity at Rajib Nagar and its surrounding area.

Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 1715 dated 30.06.2025 and informed the matter to you. As per your kind order and direction myself accompanied with SI Rajiv Subba, ASI Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Darjeeling More under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. On the way to Darjeeling More I informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel road, Arabinda Pally, PS- Siliguri, Dist. Darjeeling over mobile phone and requested him to come to Darjeeling More under PS- Pradhan Nagar with his video Camera for the purpose of Videography if required. I also informed night van officer ASI Bapi Das of Pradhan Nagar PS and directed him to come to Darjeeling More to accompany with us. At around 03.33 hrs we reached at Darjeeling More and after a while R.T. van officer ASI Bapi Das arrived there and accompany with us. I shared the information with them and briefed them properly. Then, I contacted with two independent witnesses namely Dipak Dey (M-45) S/o Subhash Dey of Ramkrishna Colony, W/No. 47, P.S. Pradhan Nagar, Dist. Darjeeling and (ii) Rabi Sha (M-22) S/o Goutam Prasad Sah of Tea Action Road, Mallaguri, P.S. Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. At around 03.35 hrs the above mentioned video grapher arrived at the spot and accompanied with us. I briefed him properly.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and cautioned and from a considerable distance we noticed that some persons were assembled near Rajib Nagar near Darjeling More under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 04 (four) accused persons while 07/08 others unknown miscreants managed to fled away through broken window and taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our nvenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which was they kept conceal inside a multi colour nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparation for committing Dacoity at Rajib Nagar and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 03.40 hrs to 04.10 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy executed by the above mentioned videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel road, Arabinda Pally, PS- Siliguri, Dist. Darjeeling as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 07/08 of their associates who fled away gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Rajib Nagar its surrounding area.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four arrested accused persons namely (i) Roshan Singh (32 yrs) S/O Late Darshan Singh of Dada Bhai Colony, Check Post, PS- Bhakti Nagar, Dist. Jalpaiguri (ii) Biplab Das (35 yrs) S/O Shyam Das of Shree colony, PO+PS- Bagdogra, Dist. Darjeeling (iii) Nipen @ Nripen Roy (18 yrs) S/O Akalu Roy of Bou Bazar, PS- Bhakti Nagar, Dist. Jalpaiguri and (iv) Bishal Routh (28 yrs) S/O Late Laxman Routh of Dharam Nagar, Coliepara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeleing and others 07/08 unknown miscreants who fled away from the spot and arrange for its investigation.
