Sir,

In producing herewith one accused person namely Sarju Tamang (27Yrs) S/O Sunil Tamang of Latpanchor, 48 Dhura, PS Kurseong, Dist Darjeeling under arrest along with following articles under proper seizure Viz :- (i) One paper made cortoon containing 05(five) bottles of "TUBORG premium beer Strong contains 650ml each bottle I.e. total(05 X 650ml = 3,250ml.) and 10(ten) bottles of "TUBORG premium beer original Green contains 330ml each bottle I.e. total (10 X 330ml. = 3300ml.) Marked as exhibit "A", out of which 01 (one) bottle of TUBORG premium beer Strong contains 650ml, taken as sample from Exhibit "A" for examination and marked as Exhibit "A1" and 01 (one) bottle of TUBORG premium beer original Green contains 330ml, taken as sample from Exhibit "A" for examination and marked as Exhibit "A2".

I, SI Rajiv Subba of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Sarju Tamang (27Yrs) S/O Sunil Tamang of Latpanchor, 48 Dhura, PS Kurseong, Dist Darjeeling, to the effect that On 30th June 2025 at around 18:10 hrs, I received specific source information that one individual was in possession of a large quantity of illicit liquor without any valid license or documents and was engaged in selling the same to customers at the Public Bus Stand, Entry Gate, Siliguri Junction, under the jurisdiction of Pradhan Nagar PS, District Darjeeling. Upon diarizing the information vide Pradhan Nagar PS GDE No. 1749 dated 30.06.2025, I informed you of the matter. Acting upon your direction, I proceeded to the mentioned location accompanied by SI Bandhan Roy, ASI Prabal Sarkar, ASI Biplab Kumar Das, and other police personnel of Pradhan Nagar PS. We were in civil dress and used a government vehicle, considering the urgency of the situation and to prevent any opportunity for the accused to escape or destroy evidence.

At about 18:20 hrs I along with the above mentioned officers and force arrived at Public bus stand, entry gate, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and being pointed by the source we detain one person,. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience) and also informed him about the information in hand. During interrogation, he disclosed his name as Sarju Tamang (27Yrs) S/O Sunil Tamang of Latpanchor, 48 Dhura, PS Kurseong, Dist Darjeeling and the accused admitted to procuring and selling illicit liquor without any license for personal profit and revealed he had been involved in such illegal activity for several days. On further search, we recovered the above seized articles from his exclusive possession.


As he willfully violated the norms of Bengal Excise Act, hence, I seized the above noted illegal illicit liquor from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 18:35 hrs to 19:00 hrs under the coverage of videography as per provisions of BNSS. Subsequently, I arrested the above noted detained person after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Sarju Tamang (27Yrs) S/O Sunil Tamang of Latpanchor, 48 Dhura, PS Kurseong, Dist Darjeeling, for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
