In producing herewith following four arrested accused persons namely (1) Suman Das @ Tempo-19yrs s/o Sarat Das of Netajinagar, near Babu singh sporting club, ward no-42, PS Bhaktinagar Dist Jalpaiguri (2) Md Najim-19yrs s/o Md Beka of Bhupindarnagar, near Bangla school, ward no-42 PS Bhaktinagar Dist Jalpaiguri (3) Pinku Paswan-27yrs s/o Promod Paswan of Promodnagar, paswan busty, near Bajrang boli mandir, ward no-42 PS Bhaktinagar Dist Jalpaiguri and (4) Pinku Roy-32yrs s/o Lt Sushil Roy of Prakashnagar near Shib mandir, ward no-42, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made hummer measuring approx 01 feet 02 inches recovered from the exclusive and Conscious possession of Pinku Paswan.
- 2) One iron made sharp cutting knife with plastic butt measuring approx 9 ½ inches recovered from the exclusive and Conscious possession of Md Najim.
- 3) One iron rod measuring approx 03 feet 4 inches recovered from the exclusive and Conscious possession of Pinku Roy.
- One screw driver measuring approx 9 inch recovered from the exclusive and Conscious possession Suman Das @ Tempo.
- 5) One Honda DIO scooty having Registration No-WB72U/2739
- I, ASI Dhurbo Misra s/o Abani Misra of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 30.06.2025 at 00:05 hrs received a specific source information that 10/11 miscreants have assembled at abundant SMC building, Don Bosco more, under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No 1612 dated 30.06.2025 and as per order I along with SI Srimanta Chatterjee, SI Youel lepcha, ASI Khagen Barman, ASI Arjun Prasad Dhayani, ASI Ratan Sarkar and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for at abundant SMC building, Don Bosco more under Bhaktinagar PS to work out the information in hand vide GDE No-1613 dated 30.06.25.

At about 00.15 hrs we arrived at the at abundant SMC building, Don Bosco more under Bhaktinagar PS as indicated by the source we noticed that 10/11 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 7/8 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making

ASI-Dholen leni 21-30/06/25 preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 30.06.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Suman Das @ Tempo-19yrs s/o Sarat Das of Netajinagar, near Babu singh sporting club, ward no-42, PS Bhaktinagar Dist Jalpaiguri (2) Md Najim-19yrs s/o Md Beka of Bhupindarnagar, near Bangla school, ward no-42 PS Bhaktinagar Dist Jalpaiguri (3) Pinku Paswan-27yrs s/o Promod Paswan of Promodnagar, paswan busty, near Bajrang boli mandir, ward no-42 PS Bhaktinagar Dist Jalpaiguri and (4) Pinku Roy-32yrs s/o Lt Sushil Roy of Prakashnagar near Shib mandir, ward no-42, PS Bhaktinagar Dist Jalpaiguri and 7/8 others also arrange for its investigation.
