I, Ranadip Mazumder, Son of Lt. Kalipada Mazumder, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against **Sri Raj Bangar (Ph- 9733088999)**, having address Green Valley Apartment, Flat No.-H, 3rd Floor, Block-4, Upper Bhanu Nagar, P.O.-Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, Pin-734001, West Bengal.

While on a routine inspection on the site having consumer id 412195490, energy meter no. BB1187790, having power connection of WBSEDCL in the name of **Sri Raj Bangar (Ph- 9733088999)** in the address Green Valley Apartment, Flat No.-H, 3rd Floor, Block-4, Upper Bhanu Nagar, P.O.-Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, Pin-734001, West Bengal, I, Ranadip Mazumder, Assistant Engineer & Station Manager, Power House CCC, WBSEDCL along with Sri Jyotiska Sengupta, Sr. Office Executive, Power House CCC, WBSEDCL and other technical staffs observed that the energy was being used unauthorizedly for commercial purpose (Production of Kulfi-IceCream) at the above mentioned premises via domestic connection.

We entered the premises at 11:10 hrs on 30.06.2025 after handing over Notice to Smt. Soni Nahata (Ph-8617832375) present during inspection. Then it was observed that the power was being used unauthorizedly for commercial purpose (Production of Kulfi-IceCream) at the above premises via domestic connection. Therefore committing a crime for theft of power as per section 135 (1) (e) of The Electricity Act 2003 amended on 2007 of India. A maximum Demand of 4.96 KW was found recorded in the energy meter as on 30.06.2025 and contractual load is 3.34 KVA. Physical load found 9.02 KW. Accordingly the connection was disconnected and the energy meter was seized and labelled. A copy of inspection report, notice and Seizure list (Bentec make, 1 Phase, 240 Volts, (5-30) amps energy meter having Serial No. BB1187790 with Last Reading-15309 KWH, property of WBSEDCL) was handed over to Smt. Soni Nahata present during inspection. We exited the premises on 12:00 hrs.

Thus you are requested to kindly initiate an investigation against **Sri Raj Bangar** under Section 135 (1) (e) of the Electricity Act 2003 amended on 2007 of India.
