- 1. That I am peace-loving law abiding citizen of India by birth according to the Article 5 constitution of India 1950.
- 2. That in 8th May 2022 accused one Rupen Chettri has approached me for a friendly loan of Rs.2, 00,000/- (Rupees Two Lacs) only for his family ailments and/or family problems.

4. That this is very unfortunate that he has not paid any amount further towards repayment of his friendly loan according to the commitment.

Photocopy of the bank statement is annexed herewith for your ready reference and which is selfexplanatory.

On the contrary when I asked him for the remaining repayment of said friendly loan Rs.1.20,000 (Rupees one lac twenty thousands) only he used filthy, nasty and most alarming languages with me, then he starts threating me as and when I called him for repayment of my money and stops taking my calls and at last he blocked my phone number.

Now I am great distress and feeling helpless, so finding no other alternative I approach you to register this complaint and to lodge a First Information Report against this notorious criminal.

So, this is my earnest request to you authority concerned please take strict legal actions against above said proclaimed offender Rupen Chettri to safe guard and/ or protect the property of the complainant.

In the view of above facts and circumstances, it is therefore humbly request to you that an enquiry may be initiated on the basis of this complaint against the accused person being the fraudsters of the concerned locality who are involved in the above said incident subsequently.

Therefore, it is submissive appeal to initiate a First Information Report (F.I.R.) against the above named accused person and to make an enquiry in accordance with law, as early as possible in the interest of justice and to safeguard the property of complainant otherwise right, title, interest will be grossly affected.
