I, Sri Sajjan Agarwal, Son of Late Radha Krishna Agarwal, Resident of Punjabi Para, Post Office: Siliguri, Police Station: Bhaktinagar, District: Jalpaiguri, Pin Code: 734001 Mobile No: 99320-22100 the undersigned would like to draw your kind attention towards the fact that my wife Smt. Reha Devi Agarwal along with Smt. Manju Devi Agarwal, wife of Sri Om Prakash Agarwal, Smt. Saroj Devi Agarwal, wife of Basant Kumar Agarwal, Smt. Reshmi Devi Agarwal, wife of Sri Raj Kumar Agarwal, all residents of Sevoke Road, Siliguri, District: Darjeeling, purchased a plot of land vide Deed No. I-158 dated: 11th November, 2001, land measuring 1.1348 Acre, J.L No.02, Khatian no. 119, Sheet no. 04, Plot no. 2/90, Pargana- Baikunthapur, Mouza- Dabgram, District: Jalpaiguri, from Sri Binod Kumar Gupta, Son of Late Banwari Lal Gupta, Usha devi Gupta, Wife of Sri Binod Kumar Gupta, Smt. Bina Devi Gupta, Wife of Late Banwari Lal Gupta, all residents of Punjabi Para, Siliguri, District: Darjeeling. They are in the possession of the said land and have been enjoying the rights of the land without any hindrance whatsoever. We have deputed one security agency and to that effect security guards were installed out there. Today morning, we came to know that yesterday night some antisocial elements numbering around thirty people or more trespassed into the land forcibly. They broke and took away tin sheds, pipes, water tank, etc. and also kidnapped the two security guard posted there. As per the information we received, the persons involved in this crime are:

These persons, in connivance with the BL and LRO office, Rajganj have manipulated the records of rights recorded in our name and we are anticipating that the BL& LRO Office and Officials are also involved in this matter. They are trying to forcibly take illegal possession over the said land.

Therefore, I request you to initiate appropriate legal proceedings against the accused persons as per provisions of law for kidnapping, illegally take over the possession of land and creating nuisance.
