Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Supen Hazra (56 yrs), S/O- Lt. Goli Lal Hazra of Tarijote, Deonia More, PO- Newrangia, PS- Matigara, Dist- Darjeeling and 11 (Eleven) bottles of Himalayan TukTuk Country spirit each bottle containing 600 ml and in total 6.6 Literas seized articles. The ground of arrest duly been communicated with him.

I, ASI Bikash Roy, of Matigara PS, SPC under your kind control beg to state that on 30.06.2025 during special evening patrolling van duty, I received a secret source information that one person as noted above is selling liquor illegally from his house located at Tarijote, Deonia More, PO- Newrangia, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with C/868 Sujal Roy, and C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for Tarijote, Deonia More under Matigara PS to work out the information in hand. At 20.30 hrs we arrived at Tarijote, Deonia More in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his house located at Tarijote, Deonia More, PS- Matigara, Dist- Darjeeling for his wrongful gain. On being search his house, the above noted liquor were recovered. On demand he failed to produce any valid documents/license in respect of store/sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 20.40 hrs to 21.00 hrs on 30.06.2025 under videography. Videography done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Supen Hazra (56 yrs), S/O- Lt. Goli Lal Hazra of Tarijote, Deonia More, PO- Newrangia, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
