Sir,

I, SI Soumik Paul of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Kush Das (25) s/o Bimal das of Ambikanagar road No 01 PS New Jalpaiguri Dist.- Jalpaiguri under arrest along with following seized articles;

1. 12 (Twelve) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that on 30.06.2025 at 13.45 hrs received source information that one person was selling Liquor illegally at Jiyaganj near Pradip Hotel under PS- New Jalpaiguri, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with ASI Manoj Majumdar, C/1462 Sajan Tamang, VP- 13 Jamirul Islam, CV-824 Niru Yadav all of NJP PS, SPC left for Jiyaganj to verify the veracity of information vide NJP PS GDE No. 1530 Dated- 30.06.2025. On arrival at the spot at 14.05 hrs it was found that one person mentioned above was selling liquor illegally at Jiyaganj to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 30.06.25 in between 14-15 hrs to 14.35 hrs. (seizure Total approx 7.2 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Kush Das (25) s/o Bimal das of Ambikanagar road No 01 PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.


