- I, ASI Manoj Majumdar of New Jalpaiguri PS, Siliguri Police Commissionerate , do hereby lodge written complaint, on producing one arrested accused person namely Radha Gurung (35/F) d/o Podam Bahadur Gurung of Binay more PS New Jalpaiguri, Dist-Jalpaiguri under arrest along with following seized
 - 12 (Twelve) Nos sealed Bottles of Himalayan Gold 60 up Indian Made Liquor each bottle containing 600 ml, Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that on 30.06.2025 at 16.15 hrs received source information that one person was selling Liquor illegally at DS Colony, New Jalpaiguri Station main road under PS- New Jalpaiguri, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with ASI Manoj Majumdar, C/1462 Sajan Tamang , VP- 08 Laxman Roy , LCV-355 Basana Choudhury all of NJP PS, SPC left for DS Colony, to verify the veracity of information vide NJP PS GDE No. 1544 Dated- 30.06.2025. On arrival at the spot at 16.20 hrs it was found that one person mentioned above was selling liquor illegally at DS Colony, New Jalpaiguri Station main road to her designated customers to earn huge money for her livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked she disclosed her name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from her possession and seized the same as per proper seizure List and labelled duly signed by her and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed her guilt. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 30.06.25 in between 16.20 hrs to 16.35. (seizure Total approx 7.2 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Radha Gurung (35/F) d/o Podam Bahadur Gurung of Binay more PS New Jalpaiguri, Dist-Jalpaiguri and arrange for its investigation.
