Sub: Requesting to Lodge Complain about theft of 12.5 Kgs Silver on transit from Kolkata to Siliguri via Bus Aitiana Airways WB 73 G 9877.

Respected Sir,

I, Anish Goyal director of Equinova Vyapaar Private Limited have sent my staff Nawrangi Singh, S/o Bhuledan Singh, permanent residence at Vill. Itwan Tula, Jankipur, Post — mEhiyan, P.S. Tandwa, Nabinagar, Aurangabad, Bihar — 824301, bearing Aadhar Card No. 370513860717 was assigned the responsibility to transport 12.5 kg of silver to Mr. Gopal Kumar Agarwal, whose address is Old Sona Chandi Building, Naya Bazaar, Khalpara, Siliguri — 734005. The company is registered in 276, Rabindra Sarani, 2nd Floor, Room No 7, Kolkata-700007.

The delivery was made against Bill No. EVPL-2526-012 dated 25.06.2025 and was to be executed by road via Aitiana Airways Bus (Registration No. WB 73 G 9877) on 25.06.2025. The payment for the goods was to be made at the time of delivery.

The silver consignment was securely packed in a packet, placed inside a sealed box with rubber guard protection, and kept within a small cloth bag. Throughout the journey, the staff personally ensured the safety of the bag, always keeping it on his seat.

The sequence of events is as follows:

- 1. He boarded the bus with the bag and kept it with him.
- 2. During dinner halt at Krishnanagar, he deboarded briefly. Upon reboarding, the bag appeared to be intact.
- 3. A second halt was made at **Dholkhola** where he again deboarded momentarily to use the restroom. On my return, the bag remained on the seat, appearing undisturbed.
- 4. At the final stop, Tenzing Norway Bus Stop, while deboarding, he noticed the bag felt significantly lighter.
- 5. Upon immediate inspection, he found that while the outer bag and sealed box were visually intact, the entire 12.5 kg of silver had been stolen from inside.

I am therefore requesting the concerned authorities to kindly register this complaint and initiate a thorough investigation at the earliest. I also request all necessary assistance in recovering the stolen goods.
