That on 27/6/25 I demanded sum of Rs 2 lakh from said Mamta Thakur which was due and payable by her to me. She immediately on 30/6/25 informed me through her mobile to come to her shop on side/next lane of my residence. Her shop Champasani PS. Pradhan Nagar. Her mobile No 7001147835. I entered her shop at around 6:40 to 6:45 PM on 30/6/25 upon her calling me.

On 30/6/25 at 6:45 PM as I entered shop of Mamta Thakur I found her daughter Kirti, her husband and two male miscreants present there. When I demanded my amount of Rs 2 lakh from her (Mamta Thakur) she refused to return my money after a bit argument I left the shop but from backside Mamta Thakur, her daughter, son in law started uttering slang language and bad words on me. They provoked and started using bad language, and told come to shop inside we will give you money. When I returned back they all of them assaulted me physically and thereafter Mamta Thakur attacked me with Sissor that was in her shop towards me badly which could be fatal. I somehow resisted causing deep wounds in my left hand thereby causing grievous hurt by dangerous weapon.

That out of attack and assault by Mamta Thakur,
Her daughter Kirti and her husband I was not in
my senses at her shop.

That later was recovered by my husband
and I sustained grievous wound on my left hand by
Sissor attack, being grievous weapon, I was medically
treated at Siliguri District Hospital on 30/6/25 at 8:40PM.

I therefore was late in lodging my written
Complain as I was medically unfit and weak.

I therefore request your good self to protect
me and my family from said Mamta Thakur, her
daughter Kirti including her husband and others present
with her on 30.6.25 in her shop.
