Subject: - F.I.R.

Sir,

With due respect, I am producing herewith one accused person namely Ganesh Sah (30 yrs) S/O Chandrika Sah of Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles viz :- (i) one paper made cortoon containing 12 (twelve) bottles of "TUBORG premium beer Strong each bottle containining 650 ml I,e total (12 x 650 ml = 7.8 ltrs) -Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as exhibit "A1" (ii) One starlight blue colour TVS Jupiter Motor Cycle (Scooter) displaying registration number WB/74/BC/6393 with its key - Marked as Exhibit "B".

I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Ganesh Sah (30 yrs) S/O Chandrika Sah of Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 02.07.25 at 20.30 hrs I received source information that one person would be come to Gate Bazar from Darjeeling More side in a motor Cycle (scooter) with huge quantity of illicit liquor inside the dicky of the scooty with a view to sale the same to his design customers at Gate Bazar. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 121 dated 02.07.25 and informed the matter to you. As per your kind order and direction, I along with SI Rajiv Subba, ASI Biplab Kr Das and force all of Pradhan Nagar PS left for Promod Nagar by Govt vehicle with investigation kit to verify the veracity of the information. At around 20.45 hrs we arrived at Promod Nagar and contact with my source and at around 20.55 hrs being identified and shown by the source I noticed that one scooter was coming from Darjeeling More side and proceeding towards Gate Bazar side. I managed to stop the said scooter at Promod Nagar and managed to detain the rider of the scooter (WB/74/BC/6393). On interrogation he disclosed his identity as noted above. On search the scooter having registration number WB/74/BC/6393 we recovered the above noted articles which were kept hidden inside the dicky of the said scooter. On demand he failed to produce any documents in respect liquor recovered from his possession. During local enquiry it could be revealed that the person namely Ganesh Sah (30 yrs) S/O Chandrika Sah of Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling, is running such type of illegal business of selling illicit liquor without any valid documents for his wrongful gain. As the accused person Ganesh Sah (30 yrs) S/O Chandrika Sah of Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling has violated the norms of Bengal Excise Act, further I seized the above noted articles under proper seizure list in presence of witnesses and after informing his ground of arrest I arrested the accused person under proper memo, and brought to the Pradhannagar PS to proceed further legal procedure. The whole process of search and seizure was made under the coverage of video graphs in between 21:05 hrs to 21:25 hrs at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Ganesh Sah (30 yrs) S/O Chandrika Sah of Gate Bazar, PS- Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
