With reference to the above subject
Shristy Choudhary, wife Navneet Agarwal,
resident of Babupara, Goshala Road, near
Marble house, Siliguri-734005, would like
to state that on 29-5-2025 at about 9.10 p.m.
I and my husband went to visit my
maternal uncle's house on Jarnawal
Bajaj Street, Behind R.R. Apartment,
Khalpara, Siliguri-734005.

After a short while Mr. Anil Roy rang
the door bell of my uncle's flat and
on opening the door he was seen on
the door of his own flat. He rudely
told to remove the motor bike parked
on the side of approach road. All of a

suddenly he started running towards the ground floor shouting that "Look what I do to your bike" bearing registration number BR37F9793. By the time we reached at the site of parking I found that my bike was tilted on on the boundary wall. On seeing the condition hot altercation started between us and Smt. Dimple Roy exchanged blows and hurt left side of my face with heavy swelling. Finding no other alternative my husband personally reported the matter in Srigaon Police Station and I dialled '100' helpline and after a short while police vans from both the places arrived and after necessary investigation left the place of occurrence. Due to the injury I visited the Sadar Hospital the same day I was administered necessary medicines by the doctor on duty. (copy enclosed).

Be it mentioned that at the time of incidence on ground floor Mr. Akshay Roy, & Anil Roy, threatened my aunt, Mrs. Kanta Dudani, with dire consequences and asked her to forbid her relative to visit their house. My aunt is aged

about 51 years and suffering with multiple complex diseases (COPD, Diabetes, Hypertension, Gall Stone, uric acid, CKD etc) copy of reports enclosed. Torture on her by the Ray family may result in severe illness and can be fatal. My uncle Bejoy Kumar Agarwal alias Dudhni is aged about 70 years and an old man. He is mentally tortured so that he vacates the rented flat. The Ray family forbids my uncles family and their guests to use the space outside their main door for keeping slippers and shoes which has forced them to use the space within the flat. There is every possibility that things might escalate in future.

In view of the above facts and circumstances I request you to look into the matter for which I shall be highly obliged to you.
