In producing herewith following three arrested accused persons namely (1) Amzad Ahmed-46yrs s/o Lt Abdul Hakim of Asrafnagar, near Maszid, ward no-40, PS Bhaktinagar Dist Jalpaiguri (2) Md Habib-34yrs s/o Lt Md Hadish of Asrafnagar, ward no-40, PS Bhaktinagar Dist Jalpaiguri (3) Kamal Thapa-30yrs s/o Gopal Thapa of Kholachand Fapri, near Bhanu chalk statue, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made Plier with plastic cover butt measuring approx 8 inches recovered from the exclusive and Conscious possession of Md Habib.
  - 2) One iron rod measuring approx 03 feet 4 inches recovered from the exclusive and Conscious possession of Amzad Ahmed.
  - 3) One screw driver measuring approx 9 inch recovered from the exclusive and Conscious possession Kamal Thapa.
  - 4) One Bajaj Pulsar 150 motor cycle having Registration No-WB74BF/3099 which was lying at the PO.
  - 5) One Oppo mobile phone of Amzad Ahemed having IMEI No-869054055837097 & 869054055837089 with Sim no-8945958336
  - 6) One Oppo mobile phone of Md Habib having IMEI No-861148062815894 & 861148062815886 with Sim no-9679470970
  - 7) One blue colour redmi mobile phone of Kamal Thapa having IMEI No-860815061467015 & 860815061467023 with Sim no-7586821408
- I, ASI Dhurbo Misra s/o Abani Misra of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 7/8 others to the effect that on 03.07.2025 at 00:10 hrs received a specific source information that 10/11 miscreants have assembled at 3<sup>rd</sup> Mile, Salugara in front of Jiwan Deep Building under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No 111 dated 03.07.2025 and as per order I along with SI Youel Lepcha, SI Maheswar Chandra Paul with force (K-37 PS Mobile), ASI Khagen Barman, ASI Dipak Karmakar, ASI Mukul Bosu (CS-III mobile officer), and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for 3<sup>rd</sup> Mile, Salugara in front of Jiwan

As 1- Dhulea llecin dr-03/07/25 Deep Building under Bhaktinagar PS to work out the information in hand vide GDE No-112 dated 03.07.25.

At about 00.25 hrs we arrived at the at 3rd Mile, Salugara in front of Jiwan Deep Building as indicated by the source we noticed that 10/11 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 7/8 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 01.07.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Amzad Ahmed-46yrs s/o Lt Abdul Hakim of Asrafnagar, near Maszid, ward no-40, PS Bhaktinagar Dist Jalpaiguri (2) Md Habib-34yrs s/o Lt Md Hadish of Asrafnagar, ward no-40, PS Bhaktinagar Dist Jalpaiguri (3) Kamal Thapa-30yrs s/o Gopal Thapa of Kholachand Fapri, near Bhanu chalk statue, PS Bhaktinagar Dist Jalpaiguri and 7/8 others also arrange for its investigation.
