Ten (10) bottles of "KINGFISHER Imperial Strong Beer", each contains 650 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-A. 2. Ten (10) bottles of "PRAKASH60 60" UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B. I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this 526 started written complaint against the arrested accused person namely Basu Sen Thakuri, aged 46 yrs, s/o-Late Basanta Sen Thakuri, resident of Rail Colony, Bagdogra Station more, Dumrigudi, PS-Bagdogra, Dist- Darjeeling to the effect that on 12.06.2025 at 12:05 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect namely D+ 12-06 25 Basu Sen Thakuri at Rail Colony, Bagdogra Station more and the same has been selling illegally V/s 46 A/c) from that house cum shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS. This refers to Bagdogra PS GDE No. 522 dated 12.06.2025. Then as per direction of O/C Bagdogra PS, at 12:10 hrs I along with SI Binup Mahato, ASI Amit Lama, ASI Munna endonsed to Ahmed, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Rail ASI Nined Colony at Bagdogra Station more under Bagdogra PS, SPC to work out the secret source information. This refers to Bagdogra PS GDE No. 523 dated 12.06.2025. Under these ch Pof for circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 00:20 hrs we investigation reached at Rail Colony at Bagdogra Station more and after a while being indication & identification by source we held raid at the house cum shop of the suspect Basu Sen Thakuri and managed to apprehend the suspect with the help of accompanying Police personnel and interrogated him. On 12/06/24 ar Drakuri, resident of Rail Colony, Bagdogra Station more, Dumrigudi, PS-Bagdogra, Dist-Officer of S. Darreeling and introduced himself as the owner of that house cum show W. Officer in S. Darjeeling and introduced himself as the owner of that house cum shop. We disclosed our identity Biswakarma resident of Ball. Biswakarma, resident of Railway Colony, Bagdogra Station more, Dumrigudi, PS- Bagdogra, Dist-Darjeeling (Ph. No. 9641018850) agreed to be present there as independent witness. Then, we searched the house cum shop of the suspect Basu Sen Thakuri in presence of the independent witness as well as the Police personnel. On search, the above noted liquor was recovered from the house cum shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Basu Sen Thakuri (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 12:37 hrs and 12:50 hrs on 12.06.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Basu Sen Thakuri, aged 46 yrs, s/o- Late Basanta Sen Thakuri, resident of Rail Colony, Bagdogra Station more, Dumrigudi, PS- Bagdogra, Dist-Darjeeling and arrange for its investigation.
