In producing herewith the accused person namely Smt. Sumu Majhi, aged 52 yrs, w/o- Late Chhutu Majhi, resident of Bhujiapani, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 529593450243) under custody along with following seized articles under proper seizure list:

1. Ten (10) ltrs 'Chullu' in two plastic jars each of 05 liters and marked as Exhibit-A.

Eight (08) bottles of "HIMALAYAN GOLD 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B. (Total 14.80 ltrs, total value Rs. 1280/-)

I, SI Binup Mahato of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Smt. Sumu Majhi, aged 52 yrs, w/o- Late 1366, Stanted Chhutu Majhi, resident of Bhujiapani, PS- Bagdogra, Dist- Darjeeling to the effect that on 30.06.2025 at 14:50 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect namely Smt. Sumu Majhi at Bhujiapani and the same has been selling illegally from that house cum shop for her wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with C/1509 Sourav D+ 30.06.25 Roy Sarkar, LC/1202 Nilima Tamang, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Bhujiapani under Bagdogra PS, SPC to work out the secret source U/3 46 AC) information. This refers to Bagdogra PS GDE No. 1361 dated 30.06.2025. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 15:10 hrs we endused to reached at Bhujiapani and after a while being indication & identification by source we held raid at ASI Balanathe house cum shop of the suspect Smt. Sumu Majhi and managed to apprehend the suspect with the help of accompanying lady Police personnel and interrogated her. On interrogation, she revealed her identity as Smt. Sumu Majhi, aged 52 yrs, w/o- Late Chhutu Majhi, resident of Bhujiapani, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 529593450243) and introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. One Anil Oraon, aged 38 years, s/o- Late Tetengi Oraon, resident of Bhujiapani, Rajajhar, PS-Office in Charles Majhi, resident of Bhujiapani, PS Bardon Fulmoni Majhi, aged 22 years, do- Late Officer P Chartu Majhi, resident of Bhujiapani, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7477309891) agreed to be present there as independent witness. Then, we searched the house cum shop of the suspect Smt. Sumu Majhi in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, she failed to produce any valid document/license for stocking, possessing & selling that liquor. She confessed that she had been stocking, possessing & selling liquor illegally from her house cum shop since long time for her wrongful gain. Her involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Smt. Sumu Majhi (as noted above) with the help of accompanying LC/1202 Nilima Tamang after observing all legal formalities and communicating her the ground of arrest in writing as she has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 15:15 hrs and 15:30 hrs on 30.06.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person Smt. Sumu Majhi, aged 52 yrs, w/o- Late Chhutu Majhi, resident of Bhujiapani, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 529593450243) and arrange
