In producing herewith the accused person namely Fuljence Uraon, aged 49 yrs, s/o- Late Prakash Uraon, resident of Taipoo, Kothi Line, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 7290 8377 9982) under custody along with following seized articles under proper seizure list:

1. Five (05) ltrs 'Chullu' in ~~one~~ plastic jars of 05 liters and marked as Exhibit-A.
 2. Ten (10) bottles of "HIMALAYAN GOLD 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.
 3. Four (04) bottles of "COSMOS FIFTY 50° UP India Made Liquor Deluxe Whisky", each contains 750 ml @ Rs. 250/-, out of which 01 bottle is taken out as sample and marked as Ex-C.

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Fuljence Uraon, aged 49 yrs, s/o- Late Prakash Uraon, resident of Taipoo, Kothi Line, PS- Bagdogra, Dist- Darjeeling to the effect that on 30.06.2025 at 16:55 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect namely Fuljence Uraon at Taipoo, Kothi Line and the same has been selling illegally from that house cum shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with ASI Amit Lama, C/1509 Sourav Roy Sarkar, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Taipoo, Kothi Line under Bagdogra PS, SPC to work out the secret source information. This refers to Bagdogra PS GDE No. 1368 dated 30.06.2025. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 17:25 hrs we reached at Taipoo, Kothi Line and waited there for source indication. After a while being indication & identification by source we held raid at the house cum shop of the suspect Fuljence Uraon and managed to apprehend the suspect with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Fuljence Uraon, aged 49 yrs, s/o- Late Prakash Uraon, resident of Taipoo, Kothi Line, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 7290 8377 9982) and introduced himself as the owner of that house cum shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. One Manoj Sharma, aged 32 years, s/o- Rajendra Sharma, resident (Ph. No. 9635523336) and Aurangzeb Ansari, aged 35 years, s/o- Late Chhedi Ansari (Ph. No. 8116262655), both are resident of Taipoo, Kothi Line, PS- Bagdogra, Dist- Darjeeling agreed to be present there as independent witness. Then, we searched the house cum shop of the suspect Fuljence Uraon in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he had been stocking, possessing & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, I arrested the involved accused Fuljence Uraon (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 18:00 hrs and 18:15 hrs on 30.06.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person Fuljence Uraon, aged 49 yrs, s/o- Late Prakash Uraon, resident of Taipoo, Kothi Line, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 7290 8377 9982) and arrange for its investigation.
