Sir,

This has reference to the enclosed attachment, a threat message has been received through email to PGO, Bagdogra today on 29.06.2025 at 1015 hours at Bagdogra Airport. The message details given below:

"Powerful explosive devices are hidden inside backpacks placed around the Airport.

You must evacuate the building urgently.

You must hurry, or the people inside will die, lose their arms and legs, or even get decapitated.

WE, "Roadkill" and "Kyo" are the culprits behind this terror attack.

GIVE A COPY OF THIS MESSAGE TO THE NEWS OUTLETS."

In view of above, this office received the information of the same at 1030 hours from the ATM. Accordingly, a BTAC has been convened at 1100 hours.(copy enclosed)

All the members have examined the threat message thoroughly and found non-specific in nature and filled up the BWAf & BTRF as per SOP (copy enclosed) and checked all the area, found normal and obtained clearance from all stake holders. Subsequently, it is decided to enhance security precautionary measures by enhancing random check at Departure area /PESC area, maintain to enhance SLPC measure by Airline Operator and extra care for profiling of passengers for another 24 hours.

This is to inform that several times this type of threat messages have been received and in this regard a communication also has been received from CHQ/BCAS office as a guideline for filing a FIR complain on the matter as to meet up /initiate the proper investigation and find out the culprit.

Hence, This communication may be treated as FIR complain Submission to your good office and it is requested to proceed for proper findings in the matter and status of the investigation may please be conveyed to this office for onwards reporting to the appropriate authority accordingly.
